Dear Mr. Leonhardt:

I am writing you to request reimbursement from the City of Milwaukee in the amount of \$417.65 for financial loss I suffered due to the unnecessary and illegitimate removal of my 1992 Geo Metro automobile from its parking place in front of my house and the numerous acts of negligence and errors of judgment which resulted in the refusal to return the car to me. This resulted in my having to make four trips from my home on the northwest side Milwaukee to the City's tow lot on the south side of Milwaukee, plus two unnecessary trips to the City of West Allis Police Department and one unnecessary trip to the Wisconsin Department of Motor Vehicles.

This financial loss consists of the following items:

Loss of income due to loss of 15 1/2 hours of work during the period of Oct. 31 through Nov. 3	\$232.50
Transportation costs for multiple trips to the city's tow lot, West Allis Police Department, and the state DMV	26.15
Paying neighbor to take me to the tow lot to retrieve my car	25.00
Citation	30.00
Towing and storage fees	104.00
