

On July 15, 2003, my son were arrested on 27th & Hope off of Capital Drive, at 12:30 a.m. In the meantime he were taken to jail. On two tickets he received when he were in middle school coming from work. I received a called at 2:22 a.m. in the morning stating I needed to bring \$125.00 to 7th district in order for him to be released. He was driving my car a 96 Olds Mobile Cutlass Supreme, Four door, Red. When they took him to jail they did not secure the car. I were told that the plates was suspended. Nor were the car lock when they took him to jail.

After, about two hours had passed I received another called from an officer that my car had been vandalized. I need to come right away to the 7th district station. When I made it to the station the officers told me he would let my son go. One other officer asked me did I have insurance on the car. When I asked him why wasn't I informed earlier about my son and my car they told me they didn't have to call me because he is 17 years of age. **I said, "Why would you call me now that my car have been vandalized, so now you're letting him out without payment," and now you want to offer me a tow. Why didn't you have it towed when you arrested him, if the plates were suspended? The officer stated he were doing me a favorite by not having the car towed. This were before I had seen my car. If you had had it towed none of this would have happen, now would it.** I t was about 4:30 a.m. when my son and I went to retrieve my car and seen what damage had been done. They even allowed him to drive the car home. **Then one of the officer stated, "It is not our responsibility if he get stopped driving the car.** No one bother to follow us to the car to do a report. even after I stated what about my car. It took them almost a week and half to get some type of report done and that only because I call my attorney that's the only way I received the report that I have sent to you, and it is not right, because no one bother to even come and look at the car. I have tried to get the officer to come, but he refused. He told me it wasn't his job to come out and do a report after the fact. This just a **summary** of what happen.
