B. Fence (continuation)

- wooden gate between the house (bock) and the detached garage will be replaced with a metal feare with privacy sheet, and the same design with the metal feare.

- wooden gate facing the street (Kemilworth) will also bereplaced with a metal gate with pillar at the corner and the same design with the proposed metal feare.

F. Railing on upper front porch

- install 15" metal railing on top of the ledge
which has 16 1/2" ht. from inside

- metal railing is the same as the (metal) design
of the metal fence
