The statement of Edgar Ayala 1128 W Mineral Street Milwaukee, Wisconsin 53204. Age 15. Regarding the incident which occurred on February 11, 2003 at about 6:45 AM at the intersection of 11th and Washington in Milwaukee, Wisconsin.

When the above mentioned incident occurred, I was on my way to school. I boarded the bus at 11th and Mineral and sat in the rear seat on the door side of bus. I was alone. The weather was dry and not snowing. The bus was going south on 11th Street and approached the 4-way stop at the Washington Street intersection. The bus did come to stop at the stop sign. The bus then started to move forward and then continue straight through the intersection. I first saw the jeep when the bus was about in the middle of the intersection. The jeep was east on Washington and approaching the stop sign. The jeep was moving when I first saw it. It appeared the jeep could not or did not stop for the stop sign. The jeep continued to move forward until it struck the bus. The front of the jeeps hit the bus at the rear door area. It was a minor accident. There was not much the bus driver could do to avoid this accident because the jeep kept moving forward until it hit the bus. The bus driver did ask me to fill out a card which I did. I was not injured. I have read my statement and it is true and accurate.
