Re: Report of the Renewal Application of Jasmeet Singh for a Public Passenger Vehicle Driver License.

FINDINGS OF FACT

1. Jasmeet Singh (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver License in the City and County of Milwaukee, Wisconsin. Said license expires at midnight, October 31, 2019.
2. An application to renew said license was filed with the Office of the City Clerk.
3. On September 18, 2019, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes, of a police report that could form the basis for suspension or non-renewal of the license and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on October 2, 2019 at approximately 9:30 a.m. in Room 301-B of City Hall. At said date, time and place, licensee did appear, and was not represented by counsel.
4. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. Notice was sent to Jasmeet Singh at 3265 South 60th Street, Milwaukee, Wisconsin 53219, along with a copy of the police report on September 18, 2019 in an envelope which was sent by U.S. first-class prepaid mail in an envelope bearing the return address of the License Division, 200 East Wells Street, Room 105, Milwaukee, Wisconsin 53202. The address of 3265 South 60th Street, Milwaukee, Wisconsin 53219 was the address given by the applicant on his renewal application. The licensee did appear at the hearing and admitted receipt of the notice of hearing, and the envelope containing the notice and police report was not returned to the License Division by the U.S. Postal Service.
 - B. On November 14, 2018, the licensee was charged in Milwaukee County with Child Enticement-Expose Genitals/Pubic Area/Intimate Parts (Felony) and Resisting or Obstructing an Officer (Misdemeanor).

Charge 1: Child Enticement-Expose Genitals/Pubic Area/Intimate Parts
2: Resisting or Obstructing an Officer

- C. The licensee stated he is in school and also working for American United. He stated the incident occurred two years ago while he was driving a cab, but not on duty. He added that he just wanted to get the trial over with because he does not believe the district attorney has the evidence to convict him. He stated that he believes that his accuser was forced to pursue legal action against him.
- D. Alderman Bauman moved to denial based on the allegations in the police report. (Prevailed 5-0)

CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
2. Based upon the above facts found, the Committee concludes that the licensee, Jasmeet Singh, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver License based upon allegations in the police report.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Works Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Public Passenger Vehicle Driver License held by Jasmeet Singh based upon allegations in the police report.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee recommends by a vote of **five (5) ayes** and **zero (0) noes** that the Public Passenger Vehicle Driver License of Jasmeet Singh be denied based upon allegations in the police report.
