Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 01/25/06 at 11:38 am, Milwaukee police were dispatched to 3244 N 26th Street for a Sexual Assault complaint. Officers spoke to the caller who stated a known actor sexually assaulted her daughter sometime in October of 2005 at the Economy Inn. She further stated the suspect took her daughter to the hotel, provided alcohol and marijuana to her, then performed sex acts and had sexual intercourse with her daughter. The victim is too young to consent to this activity.
- 2. On 03/14/06, Milwaukee police were dispatched to 7284 W Appleton Avenue for a Battery complaint. Officers spoke to the victim who stated she was struck by an unknown female as she attempted to clean the rooms at the Economy Inn. The victim was unable to identify the suspect and a report was filed.
- 3. On 07/18/06 at 11:23 pm, Milwaukee police were dispatched to 7284 W Appleton for an Armed Robbery. Officers spoke to the victim who stated he was staying the Economy Inn and had just pulled into the parking lot and was eating his dinner in his auto when three males approached his vehicle, one producing a gun, and demanded his money. The victim gave the suspects \$300 in cash and the subjects fled the scene.

- 4. On 09/04/06 at 12:47 pm, Milwaukee police were dispatched to 7284 W Appleton for a Fight complaint. Investigation revealed the victim and suspect got into a heated argument, that turned into a physical altercation. During the fight, the suspect stabbed the victim in the back with a knife, causing a laceration. Victim was conveyed to the hospital and taken immediately to surgery for a possible punctured lung.
- 5. On 10/21/06 at 12:06 am, Milwaukee police were dispatched to 7284 W Appleton for an Armed Robbery complaint. Investigation revealed that the victim and a friend were smoking crack inside a room at the Economy Inn with the victim stating she was robbed of her coat by an unknown female. It was later learn the victim knew this woman who took her coat and a theft report was filed.
- 6. On 03/09/07 at 8:31 pm, Milwaukee police were dispatched to 4750 N 31st Street regarding a Sexual Assault that took place at the Economy Inn. The victim, who was fourteen years of age, stated three actors, whom she had just met, engaged in sexual intercourse with her. Victim indicated that subjects used physical force to hold her arms and that this was done without consent.
- 7. On 03/30/07 at 3:19 am, Milwaukee police were dispatched to 7284 W Appleton for a Strong Arm Robbery complaint. The victim stated he has a room at the Economy Inn and was in the stairwell just outside his room when an unknown subject demanded the victim to give up his money. The victim stated he feared for his safety and let the suspect go through his person. Taken was his wallet that contained three hundred dollars and his cell phone. The suspect then fled. No injuries were reported.
- 8. On 08/04/07 at 2:27 pm, Milwaukee police were dispatched to 7284 W Appleton for a Disturbance complaint. Investigation revealed a subject who rented a room for the night accused the owners wife of stealing his cell phone. This subject became angry and started to kick and throw furniture around in the office. The subject was asked to leave but refused so police were called. The subject then left the office but continued to make threats from the parking lot. The owner exited the office and was struck by a brick that was thrown by the suspect. The owner sustained a laceration to the left side of his head. Another actor who was also on the lot and with the suspect, climbed up onto a car parked on the lot causing the car roof to buckle. Reports were filed.
- 9. On 08/27/07 at 4:43 am, Milwaukee police were dispatched to 7284 W Appleton for a Theft complaint. Investigation revealed the victim had invited some males back to her room and later found her purse to be missing. A report was filed.
- 10. On 08/31/07 at 1:10 am, Milwaukee police were dispatched to 7284 W Appleton for a Fight complaint. Investigation revealed two subjects got into a verbal argument after agreeing to come to the Economy Inn together. Both parties agreed to leave the hotel and no further action was taken.
- 11. On 09/04/07 at 1:04 pm, Milwaukee police were dispatched to 7284 W Appleton for a Suicidal Subject. Investigation was found to be baseless.
- 12. On 09/07/07, Milwaukee police were dispatched to 7284 W Appleton for a Welfare Check. Investigation revealed the subject in question was determined to be ok and the call was made baseless.

- 13. On 09/13/07 at 3:18 pm, Milwaukee police were dispatched to 7284 W Appleton for a Check For A Missing complaint. Investigation revealed that no one matching the missing description was found on the property. Officers did speak with the owner, Harjinder Singh, who stated he saw no one matching that description.
- 14. On 09/23/07 at 10:45 am, Milwaukee police were dispatched to 7284 W Appleton for a Check The Welfare complaint. Police were directed to room 122 to check on the callers female relative who was staying at the hotel. Officers located the woman along with a male subject and officers recovered drug paraphernalia from the male subject. He was arrested and charged with Possession of Drug Paraphernalia.
- 15. On 09/27/07, applicant received five citations from the City of Milwaukee for the following offenses: Building Maintenance (two citations), Annual Test of Smoke Alarms Required and Adoption of Model Fire Code (two citations).

- 16. On 10/06/07 at 11:15 pm, Milwaukee police were dispatched to a Battery complaint at 7284 W Appleton. Police spoke to Harjinder Singh who stated there was an unknown male standing near the entrance to his office who was refusing to leave. No one was injured and the subject was gone once police arrived. The battery was made baseless.
- 17. On 10/10/07 at Milwaukee police were dispatched to 7284 W Appleton for a Battery complaint. Officers spoke to Harjinder Singh who stated an unknown male walked into the motel and intentionally punched him in the face. The suspect was not found on the scene when officers arrived.
- 18. On 11/04/07 at 8:43 pm, Milwaukee police were dispatched to 7284 W Appleton for a Subject With Weapon complaint. Officers spoke to Harjinder Singh who stated a known subject was armed with a crowbar and was not welcomed on the property however kept returning. Singh stated he believed that this male was bringing drugs to the motel and trying to sell it to his customers at the Economy Inn. Officers spoke to this subject who denied selling drugs and stated that it was Singh who was armed with a crowbar. It was found that no crowbar was used by either party and officers advised the subject that he was not welcomed at the motel and a citation would be issued should he return.

- 19. On 11/07/07 at 4:40 pm, Milwaukee police were dispatched to 7284 W Appleton for a Wanted Person complaint. Officers were given the actors name and description along with a room number. Police found no such person and the call was made baseless.
- 20. On 11/21/07 at 4:40 pm, Milwaukee police were dispatched to 7284 W Appleton for a Wanted Person complaint. Officers were given the actors name and description along with a room number. Police located this subject was the information given and a routine wanted check found the subject was not wanted. Call was made baseless.
- 21. On 02/06/08 at 8:04 am, Milwaukee police were dispatched to 7284 W Appleton for a Call for Police complaint. Investigation revealed the caller stated that her boyfriend held her against her will, slapped, punched and kicked her causing pain and bruising, and forced her to have sexual intercourse. Sensitive Crimes responded and filed a report. A check in CCAP revealed no charges were ever issued.
- 22. On 01/16/08 at 11:18 pm, Milwaukee police were dispatched to Trouble With Subject at 7284 W Appleton. The caller Harjinder Singh, stated a male was refusing to leave the premises and Singh believed he was selling drugs. No drugs or weapons were found on the subject. No further action was taken.
- 23. On 02/06/08 at 8:04 am, Milwaukee police were dispatched to 7284 W Appleton Avenue for a Call For Police. Officers spoke to the victim who stated she was abducted from 1818 W Fairview Avenue by her boyfriend and taken to the hotel where she was raped and battered. A report was filed and a check of CCAP revealed no charges were issued as of 04/07/08.
- 24. On 04/09/08 at 11:56 am, Milwaukee police were dispatched to 7284 W Appleton Avenue for a Trouble With Subject complaint. Investigation revealed a customer stated she paid for a room but was kicked out. Officers advised the woman and no further action was taken.
- 25. On 10/21/2013 Milwaukee police conducted a prostitution sting at 7284 West Appleton Avenue (Economy Inn). This sting resulted in the arrest of 2 subjects, and led to the pursuit of a vehicle that refused to stop for police. One of the subjects arrested told officers that the business owner, who she knows as "Jack", told her that police were in the area. "Jack" (aka; Harjinder Singh) denied numerous times that he had tipped anyone about police conducting prostitution investigations.

26. On 03/22/2015 officers investigated a shooting at the Economy Inn, 7284 W. Appleton Av. The investigation revealed that a subject received a call to deliver drugs to a room at the Economy Inn. Upon arrival was attacked from behind by a subject in the room. A third subject came out of the bathroom displaying a handgun. The first subject pulled his handgun and both subjects fired. All three subjects were hit in the exchange. The hotel staff was cooperative and all three subjects were arrested.

27. On 01/28/21 at 5:29pm, Milwaukee Police officers with agents from the Department of Revenue conducted a license premise check at the Economy Inn, 7284 W. Appleton Ave. The agents seized four boxes of cigars from a storage space rented by the subject, Saeed M. Sheikh. The business agent stated to officers that the establishment rents a room to the subject for a \$1000 dollars a month including a room and storage space. The agents did not locate any more cigar boxes on the premise. The business agent was cooperative during the license premise check.

28. On 05/26/2021 at 2:39pm officers were dispatched to a Battery Cutting at The Economy Inn, 7284 W. Appleton Av. The officers could not locate a victim. The officers spoke with the manager, who stated there was s disorderly female that he asked to leave. He stated he heard her call 911 and make a false complaint.

29. On 03/23/22 at 9:09am, Milwaukee Police were dispatched to meet the F.B.I at 7284 W. Appleton Avenue for a subject wanted. The staff at the hotel was accommodating to law enforcement giving them keys to the room and allowing access to surveillance equipment. After a prolonged standoff, staff helped get displaced guests back into there rooms.

- 30. On 09/12/22 at 6:48p.m., officers were dispatched to a Subject with Weapon at 7284 W. Appleton Av. Investigation revealed a guest armed themselves with a brick and broke a window, after they were upset regarding a refund to their room. The employee was cooperative with the investigation, however, was unable to provide the officer with the individuals identification in order to locate the subject, who was no longer on scene.
- 31. On 12/02/22 at 8:38pm, Milwaukee Police were dispatched to 7284 W. Appleton Avenue for a battery compliant. All parties refused to talk with police and the employee was helpful with officers.
- 32. On 01/17/23 at 10:21a.m., officers were dispatched to a Sick and Injured at 7284 W. Appleton Av. The caller stated they were in the shower and when they came out, they observed their friend on the floor choking and having difficulty breathing. The caller denied there was any drug use, however, had previously advised MFD their friend had ingested cocaine prior to the incident.
- 33.On 04/30/23 at 12:05a.m., officers were dispatched to a Trouble with Subject at 7284 W. Appleton Av. Officers interviewed the caller who stated they saw individuals walking in the rear touching air conditioning units. The caller stated when they looked out of the window, the subjects left. The officers did not observe anyone or anything suspicious in the area.
- 34. On 05/11/23 at 2:52a.m., officers were dispatched to an Overdose at 7284 W. Appleton Av. Per the CAD the caller stated they came to the hotel to visit their friend, who overdosed. The employees were cooperative with the investigation.
- 35. On 05/17/23 at 7:59am, Milwaukee Police were dispatched to 7284 W. Appleton Avenue for a property damage compliant. Investigation revealed that a Disorderly Conduct Domestic Violence incident occurred at the location and the applicant was cooperative.

36. On 05/22/23 at 2:38am, Milwaukee Police were dispatched to 7284 W. Appleton Avenue for a trouble with subject compliant. Investigation revealed that a subject was not happy with the accommodations of the motel and wanted a refund but the employee only gave the subject half of what he paid. Both subjects came to an agreement on the refund and the subject left.

- 37. On 07/03/23 at 2:47am, officers were dispatched to 7284 W. Appleton Av, for an armed robbery. Officers spoke with the victim who stated that two subjects she invited to her room robbed her at gun point. The two suspects obtained money and valuables, from the victim and her friend in the hotel room. The business was cooperative and allowed officers access to the video surveillance.
- 38. On 08/01/23 officers were dispatched to 7284 W. Appleton Av, for an entry to auto complaint, time of occurrence 2:00am. The caller stated that subjects removed items from her vehicle without her consent. The business was cooperative with officers providing video.
- 39. On 09/01/23 at 7:40am, officers were dispatched to 7284 W. Appleton Av, for a battery/dv. The caller stated that no battery occurred, and assignment was regarding sexual allegations. The caller did not fully cooperate with the investigation. The allegations had nothing to do with the business.
- 40. On 09/12/23 at 12:33am, officers were dispatched to 7284 W. Appleton Av, for an armed robbery. Officers spoke with the caller who stated that a known acquaintance asked for money while pointing a gun at him. The business was cooperative with the investigation but the current manager could not access cameras, and stated the day manger could access the cameras.
- 41. On 09/18/24 at 12:45am, officers were dispatched to 7284 W. Appleton Av, for a police call of service. Officers spoke with the business who stated that a subject was outside asking for help, but left the location. Officers located the subject who stated that he no longer wanted medical attention or police services.
- 42. On 11/13/23, officers were dispatched to 7284 W. Appleton Av, for a threat complaint, time of occurrence 4:58am. Officers spoke with the caller, who stated that she got into an argument with her boyfriend, and it was escalating. The caller called and wanted the subject removed but the subject left prior to police arrival. The caller was advised to call if the subject returns.
- 43. On 12/23/23, at 10:10am officers were dispatched to 7284 W. Appleton Av, for an over dose complaint. The caller stated that her friend was outside talked to some subjects returned grasping for air. The caller called for medical attention, regarding the issue, but was unsure if the friend ingested any narcotics.
- 44. On 03/11/24, officers were dispatched to 7284 W. Appleton Av, for an over dose complaint, time of occurrence 11:46pm. Officers met Milwaukee Fire, who were performing life saving measures on a subject. Narcotics were observed in the room of the subject, and appeared the subject ingested the substance. The business was cooperative with the officers regarding the assignment.

On Monday, July 3rd, 2023, at 2:47 AM, PO Oliver PATHUMWAN and I (Squad 7340), were dispatched to the location of 7284 W Appleton Av (Economy Inn), for a complaint of an armed robbery. We were in full Milwaukee Police Officer Uniforms equipped with Axon Body Worn Cameras.

CALL INFORMATION: Comment: SISTER WAS ROBBED BY GUN POINT, Comment: PHONE, MONEY, PURSE STOLEN. MFD REFUSED.

CALLER: CANIQUA, (414) 815-0987

Upon arrival I spoke with Victim who stated that she was in Room 119 around the time of 2:15 AM when two subjects who she invited over but did not know arrived at the location. She stated that she was in the room with another subject. Victim stated the other subject was in the shower when two additional subjects arrived. Victim stated that upon their arrival to the motel room S1 displayed a black handgun and told victim that he would shoot her and then pointed the handgun at victim. Victim stated that S2 then took \$150, an Iphone 7, and a photo ID, from victim's purse and \$50 from victim's bra. Victim stated that the other subject in bathroom then came out of the shower and S1 told her to get against the wall and S2 took \$80 and a Samsung phone.

Victim stated that S1 and S2 then ran from the room.

S1 left on foot eastbound on W Appleton Av and S2 left Westbound on W Appleton Av in a white sedan.

Victim stated that she met these individuals online but did not know their names and stated it was for "A date type thing," but would not elaborate.

Rasikubhai D PATEL (W/M 06/01/1952) was the employee at the time of our arrival.

PATEL allowed us to view and download all necessary camera footage.

The room is a one-bedroom unit with a bed touching the north wall in the middle of the room and a bathroom in the southeast corner.

The subject was lying on the northwest end of the room with his head pointing to the north. The subject was only wearing black underwear and had no apparent signs of trauma anywhere on his body. Just to the east of the subject was the bed, and on the bed was the subject's wallet and a package of cigarettes.


