6. On 11/04/20 at 10:06pm, Milwaukee Police were dispatched to St Mary's Hospital 2301 N. Lake Dr. for a sick and injured complaint. Officers identified the victim of a substantial battery and located a scene at 2237 N. Holton St. Officers spoke with the clerk at the gas station who allowed officers to review video of the incident. Officers discovered that the victim was panhandling outside the location and got into a physical altercation with the suspect who was also panhandling. The suspect during the altercation struck the victim with a glass bottle causing injury. The gas station clerk stated to officers that the subjects usually panhandle near the business. When the subjects are told to leave they become verbally and physically combative.
7. On 03/30/21 at approximately 9:00pm, Milwaukee Police conducted a license premise check at 2237 N. Holton St. during the course of the premise check other officers were responding to a robbery investigation. The business was cooperative with the officers and provided video, of the incident. The video revealed that the incident took place outside on the lot of the gas station. From the video officers were able to determine the time frame of the incident, the suspect and vehicle description.

8. On 07/11/2021 at 7:24pm officers observed a pop-up tent selling Milwaukee Bucks merchandise on the parking lot of 2237 N. Holton St. The officers spoke with the subject selling the shirts. He stated he was from Ohio and did not know he needed a license. He was able to get a co-worker to the sight that had a sellers permit. The subject stated they paid the manager of the gas station \$500 to use the property. The officers spoke with the applicant, who stated he did not give them permission and wanted them removed.

9. On 08/07/2021 at 2:50am officers were dispatched to a Shots Fired at 2237 N. Holton St. The investigation revealed a patron was filling up his car with gas, when a car pulls up in front of his parked auto. The two drivers exchanged words. The driver of the second car attempted to get in the store but the clerk locked the door. The driver returned and again had words with the first subject. The car drove off and the first patron produced a gun firing at the auto. The second subject produced a firearm and shot back at the first subject. The officer spoke with the clerk and he provided the officer with video of the incident. The officers contacted the applicant and he stated he was aware of the incident and that there was no damage to the station.

10. On 04/28/2022 at 9:39pm officers conducted a license premise check at Citgo on Holton, 2237 N. Holton St. During the check the officers observed several food items to be displayed for sale after their expiration dates. The items were removed from the counter and the clerk stated he would advise his manager. The officer did speak with the agent by phone.

11. On 07/15/22 at 8:29a.m., Milwaukee Police were dispatched to a License Violation at 2237 N. Holton St. Officers were advised a caller had checked with License Division and found the licenses to the business were expired, however, they were operating. The caller stated their goal was to get the business shut down. On arrival officers did find the business was operating with expired licenses. The officer contacted the agent, who stated they had a community meeting the same day and a meeting with License Committee the next day and was informed their license would be pushed through, therefore they thought it would be ok to operate. The agent voluntarily shut down the business.

12. On 08/08/22 at 10:15a.m., Milwaukee Police conducted follow up at 2237 N. Holton regarding a violation of the business plan for the Extended Hours License. The agent expressed understanding of the security measures and stated the date of the violation the security guard called in sick.

13. On 09/15/22 at 9:51p.m., Milwaukee Police were dispatched to a Subject with Weapon at 2237 N. Holton. Investigation revealed that on 09/14/22 at 8:30p.m., security approached a subject that was aggressively panhandling in the lot of the business. When asked to leave the subject drew a machete from their pants. On 09/15/22 at 9:46p.m., the subject returned and entered the business, refusing to leave after being asked to leave. The security officer feared for their safety due to the incident the previous night and called police. Officers were advised there is an active restraining order on the subject and took the subject into custody. The employees were cooperative with the investigation.

14. On 11/22/22 at 12:27a.m., Milwaukee Police were dispatched to an Overdose at 2237 N. Holton St. Investigation revealed an employee observed a subject in the lot earlier and was trying to get the subject to leave. The employee stated they observed the subject smoke something then pass out. MFD was on scene and was able to revive the subject using Naloxone.

15. On 02/14/23 at 12:59p.m., Milwaukee Police were dispatched to a Violation of Restraining Order at 2237 N. Holton St. Officers interviewed the caller who stated the business has a valid restraining order on a subject, who was at the business panhandling. The employee showed officers video surveillance of the incident. The agent was cooperative and advised officers they would email the video surveillance footage for further investigation.
16. On 03/16/23 at 12:32p.m., Milwaukee Police were dispatched to a Violation of Restraining Order at 2237 N. Holton St. Investigation revealed a subject the business has a valid restraining order on was on the premise. The officers located the subject, who had not yet been served and placed them into custody for a warrant and to serve the Restraining Order. The employee was cooperative with the investigation.

17. On 09/10/23 at 12:41a.m., Milwaukee Police were dispatched to a battery at 2237 N. Holton St. Investigation revealed a security guard struck the victim in the arm with what appeared to be a baton three times, causing injury and the victim to be transported to a local hospital. The victim stated security threatened to hit them, to which they challenged security because they didn't think they would. When interviewed the security guard stated they asked the subject to leave, then went back inside the premise. The security guard stated when they came back outside the subject was laying on the ground. The employee was cooperative and allowed officers to view video surveillance which showed security striking the victim.
18. On 02/02/24 at 5:04p.m., Milwaukee Police were dispatched to an Armed Robbery at 2237 N. Holton St. Investigation revealed the victim was pumping gas when they were approached by an armed suspect, who demanded money then fled the scene on foot. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
19. On 04/10/24 at 5:37p.m., Milwaukee Police were assigned to work Wisconsin WINS, which checks area vendors for age compliant tobacco sales. A youth entered 2237 N. Holton St., and did purchase a pack of cigarettes from the cashier, who did not check ID. The cashier denied the sale to the officer.

On Sunday, September 10th, 2023, at 12:41 AM, while in full duty uniform equipped with an Axon Body Worn Camera activated and in a marked squad, we were dispatched to N Holton St. and E North Ave (City and County of Milwaukee) to investigate a Battery complaint.

We arrived at the gas station and spoke to a security identified as Andre D GOODWIN (B/M 12/10/1981). We briefly interviewed GOODWIN on scene. GOODWIN's co-worker/supervisor was on scene, we did not identify him, but he was armed.

Interview of Andre D GOODWIN (Security Guard):

GOODWIN stated a subject was sitting outside of the gas station door and he informed him that he had to leave. GOODWIN stated the subject walked off the property and onto the sidewalk on the Southeast side of the property. GOODWIN stated he went back into the store and then went back outside a short time later. GOODWIN stated he observed the subject on the ground and the subject wasn't moving. GOODWIN stated the subject is known to frequent the area. GOODWIN stated the subject was taken to the hospital by an ambulance. GOODWIN didn't state anything else regarding the incident.

I called both callers of the incident. One caller didn't answer and the other did. The female remained anonymous, but stated when she got to the gas station there was a subject on the ground near N Holton St. The female subject stated that she did not see anyone hit the subject, but she was informed something happened between the subject and the security guard.

I asked dispatch if anyone was transported from the location, and I was informed they transported to St. Mary's Hospital. We then changed locations to St. Mary's Hospital and located the victim.

Interview of Esteban J ACEVEDO-DIAZ (Victim):

ACEVEDO-DIAZ stated he was at the bus stop on the corner of N Holton St. and E North Ave (City and County of Milwaukee). ACEVEDO-DIAZ stated at approximately 12:00 AM on 9/10/23 the security guard from the gas station approached him and told him to move around or he would hit him. ACEVEDO-DIAZ stated he told the security to hit him, because he thought he was bluffing (Ultimately giving him consent to strike him). ACEVEDO-DIAZ stated the security guard then went and got an unknown item and hit him in the arm three times. ACEVEDO-DIAZ stated he believed the security guard stopped hitting him because he knew his arm was hurt. That was all ACEVEDO-DIAZ stated regarding the incident.

ACEVEDO-DIAZ did have visible injuries to his right arm.

ACEVEDO-DIAZ was admitted to St. Mary's Hospital at 1:07 AM and treated by Dr. FOUCHAA.

ACEVEDO-DIAZ was issued a PV-17 and a Milwaukee Police Department Community Contact Card.

Due to the pending results of the medical treatment, ACEVEDO-DIAZ was advised to notify us with the details of his injuries.

It then appears to show the security guard walking around with a baton like item and talking to ACEVEDO-DIAZ. The security guard then strikes ACEVEDO-DIAZ approximately 3 times and walks back to the parking lot.

The store clerk was cooperative with police.

Upon arrival, I spoke to the store employee identified as Majid SINGH A/M DOB 09/26/1982 who stated that he has video surveillance regarding the Armed Robbery. I observed the video footage from the an exterior camera which faces North and is in front of pump 5. The video starts at 16:58 and I observe the victim in this offense identified as Shervin MIRSHAHI A/M DOB 07/17/1987 at pump 5 trying to put gas into his car. His car a navy blue Audi which was facing Westbound. I observe a black female walk up to MIRSHAHI. The black female is described as 5'00 tall, 145 lbs, medium to dark complexion, wearing a white wrap around her hair, black puffy jacket with a white shirt underneath, navy blue sweats, black and white tennis shoes, carrying a black bag. In the video the black female approached MIRSHAHI and she is partially covered by the rear of the vehicle. I observed there to be a verbal interaction between the two. I observed the suspect then flee the scene and walk Westbound on North Av.

SINGH was cooperative during our investigation.

The video was downloaded on a USB flash drive.

On Wednesday, April 10, 2024, at approximately 5:37p, I conducted an investigation at the location of (Citgo Gas Station) 2237 N Holton (Located in the the City and County of Milwaukee) This was in partnership with the Memorandum of Understanding with Community Advocates, Coalition Coordinator the City of Milwaukee Tobacco-Free Alliance, Charlie Leonard. Wisconsin Wins Campaign (WI WINS is an intervention program designed to help the State of Wisconsin come into and stay in compliance with requirements of the federal Synar Regulations

The two teens that were assigned to this deployment were as follows:

Ava Lor (A/F, 6/2/2007)

Aidan Morrison (W/M, 11/06/2006)

Upon arrival to the location LOR and MORRISON entered the location attempting to purchase products for sale, not intended for minors. The goal was for the organization to request identification and turn the minors away after they find out both were teens and ineligible for the sale. LOR requested pack of Newport's Cigarettes from the cashier. The cashier did not request identification for proof of age from LOR. LOR completed the transaction paying \$12.84 for the single pack. LOR and MORRISON returned the vehicle and provided me the description of the person hold sold the tobacco to them. LOR and MORRISON further stated he was the only person in the location.

Product purchased- Newport's \$12.84

I then entered the location and spoke to the cashier matching their description that was provided. It should be noted that only a few minutes passed since LOR and MORRISON exited, and I entered. I spoke briefly with the cashier regarding the investigation, however the cashier didn't acknowledge the sale and manager/business agent was not present. I provided my community contact card with my information to have the business agent contact me. Future citation will be issued regarding the violation upon contact of the license agent.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
