I am and blocks away from this tavern and don't need this aggravation. I was never consulted about the operations of this tavern, apparently because I am more than 250 feet away from this establishment.

Sunday, May 16, 2021 - Motorcycle swap meet bringing vehicles into the neighborhood with the occupants drinking alcoholic beverages on their way to their cars which are parked . Some occupants actually sat on the grass and continued to drink before driving away.

Sunday, June 6, 2021 - A wedding that had a live band which played outside providing loud music that I could hear from inside my house.

Sunday, June 13, 2021 - A flea market that clogged the city streets and prevented me from being able to park from 10:00 AM to 4:30 PM. I wanted to wash and wax my car. In order to do that, one needs shade. It can't be done in the garage. I am not going to make a reservation in order to park

I called for a jeep checker for parking problems - parked more than 12 inches from the curb, parked obstructing . By the time the parking checker came, the violators had gone. This bar needs to be shut down.

I called my Alderwoman Marina Dimitrijevic and spoke to the aide Terry Williams ; . Rarely do I get a live human being on the phone. I have to leave messages. That office has a recording that says Williams will call you back but that doesn't happen unless one is persistent.

The hearing before the Licenses Committee will take place virtually on 11/09/2021 at 11:25 AM. This is a public hearing. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


