
This letter is to appeal the decision made on the file number above and request a hearing.

Dear Ms. Rodriquez:

I was given the yellow "Damage Notice Card", left by the Milwaukee Police Department, at my property located at 8738 W. Appleton Ave, Milwaukee, WI 53225. This card stated that there was only damage to the front door frame. The extent of damage to this property was totally uncalled for.

I could not get a copy of the police report for Sunday, December 9, 2007, due to its sensitive nature, but I did get a copy of the report for Monday, December 10, 2007, which told me absolutely nothing. I spoke with Lt. Joseph Erwin from the 7th precinct. He mentioned that there was a court order to search for illegal drugs.


The police emptied practically all the drawers and cabinets in every bedroom, the kitchen and both baths, they tore and ripped up carpeting in some areas and it was untouched in other areas, they ripped up the vinyl flooring, which is less than 1/8 inch thick, in the bathroom. Some cabinets and the front and rear doors were damaged.

The cabinets and doors have to be repaired or replaced, the bathroom flooring needs to be replaced and the carpeting, which was only six months old, needs to be completely replaced. All these damages have been documented by pictures. My initial estimate of the damages is about \$2,000.00. We also suffered loss of rent due to the roommate being unable to stay at the townhouse due to the damage.
