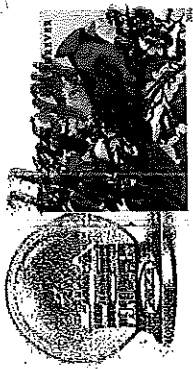

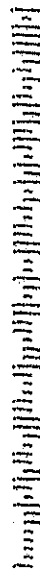

Dear Ms. Mlot:

We have received your claim for \$3,195.00, regarding damages sustained to your property on February 7, 2023 and August 18, 2023, located at 4784 S. 14th Street.

This notice of claim was filed on August 25, 2023. Wis.Stat.893.80(1d)(a) requires that a notice of circumstances of the claim be filed within 120 days after the happening of the event given rise to the claim. This service of notice is untimely.

Our investigation reveals that on February 7, 2023, Milwaukee Water Works (MWW) responded to a leak in the street reported at 1526 W. Foster Avenue. MWW crews placed the main out of service at 12:00pm, made the necessary repairs, and restored water to the main before 1:00pm. MWW further reported that on February 8, 2023, a crew responded to a leak in the street at 1403 W. Foster Avenue, and a contractor was hired to complete those repairs on February 9, 2023, and water was restored to the main at 5:30am.

On August 19, 2023, MWW responded to a leak in the street at S. 14th Street and W. Barnard Avenue. On August 20, 2023, a contractor was hired to complete those repairs and water was restored by 10:30am.

Milwaukee Water Works responded to the leak and took action in a timely manner. Since there is no evidence that the City was negligent and the claim was filed untimely, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.

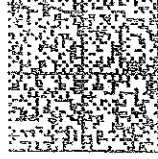
