It has been decided with all variables in mind that the homeowner is going to be pulling the permit themselves because we are friends and family. Yet, I wanted to give you the description myself in case they haven't sent it in yet. We have simplified the job all the way down to just replacing what was there and turning the one wall that was deteriorated into the Matching red brick walls in front of the house Matching red brick walls in front

2710 e Belleview -Red brick wall dismantling Off-site disposal Dumpster-Not required to be on site Wall was bulging and ready to collapse. Retaining walls (2)-Front of property 2 Cinder block walls (31") in height 2 walls 31" x 58' in length 2- perforated schedule 40 PVC will be installed behind walls to collect water and discharge 4' back from city walks 1st wall is Back-set 4 feet from public walk for water management Aesthetics: construct within the Historical Preservation Society parameters and material -A footing is required for weight of Cinderblocks -Veneered matching red brick on outside of stone to replicate original wall NSS will construct within the Historical Preservation Society parameters and material -Concrete staircase (1) Front staircase consists of 5 steps 4' width Steps: 12" depth 6 9/16" to 7" risers compliant with industry standard and step codes Style of steps -Concrete NO DESIGN CHANGE Southwest (1) -3 steps-36" width, 12" depth, 7" riser NO DESIGN CHANGE Walks have deteriorated/cracked It was imperative that (2) of the staircases needed to be dismantled immediately due to hazardous conditions. -Concrete Driveway Repair/replacement -This includes a newer aggregate base and proper grading. This will help with longevity -Removal of old concrete (off-site) -Concrete is industry standard material 6-7" Thick Rebar -Landscape repair to outside of repaired concrete -Water management For driveway On both sides of driveway (starting at front of houses), Lannon Stone pavers will be placed surface level and include a "Permeable" base to allow water to saturate before city

-Urgency of repair
-Time of year (concrete-temps)
-property owners just had eye surgery and too many tripping hazards

If I missed anything let me know. I just wanted to get this description to you as soon as I could. It took a minute to convey all the information to the property owners and get them to be OK with downsizing their project to a minimum

You should be receiving the permit request with this information very soon from Allyn Travis.

For clarity on the ordinances:

A permit shall not be required for "Retaining walls supporting less than 32 inches of unbalanced fill." (200-124-1.5-e)

252-71-2. DRAINAGE OF PAVED AREAS. a. Newly Paved or Repaved Areas Where Storm Sewers Are Available. All storm water which is generated from a newly paved or repaved area of more than 1,000 square feet, such as a parking lot, terrace or patio area, loading areas or other hard surface, shall be disposed of within the lot lines through a sewer, permeable paving, natural absorption or combination thereof without discharging to adjacent private or public property not specifically designed for this purpose. No such paved or hard surface shall be paved and contoured in such a way as to interrupt a natural drainage system serving adjacent properties. No such paved area shall be paved or contoured in such a way as to impose a greater drainage burden on adjacent property. b. Newly Paved or Repaved Areas Where Storm Sewers Are Not Available. Where no public storm sewer is available or where the commissioner determines that natural absorption, permeable paving, or combination thereof may accommodate all on-site water within the property, the commissioner may allow a drainage system which is not connected to a storm sewer. The commissioner may request soil borings, absorption tests, engineering calculations prepared and sealed by a registered civil engineer or other information to verify that the water can be disposed of within the property. No water shall be drained across or onto a public street or private property under different ownership than the property generating or containing the surface water. c. Permeable Paving. The commissioner may allow the use of permeable paving as regulated in s. 252-74. For newly paved areas or parking lots, the storm sewer requirement under s. 225-4 may be waived by the commissioner if adequate drainage is provided.
