## **NOTICE OF PUBLIC HEARING**

CITY OF MILWAUKEE - City Plan Commission 809 North Broadway Milwaukee, Wisconsin

PLEASE NOTE: This hearing relates to the property within the boundary shown on the map on the reverse side of this notice. If your property is not within the zoning boundary, then you are receiving this notice because your property address is within 200 feet of the subject site.

## PERSON OF INTEREST:

The Common Council has referred File No. 250888 to the City Plan Commission (CPC) for recommendation. This file relates to the change in zoning from Local Business, LB2, to Two-Family Residential, RT4, for the property located at 2560 North Teutonia Avenue, on the east side of North Teutonia Avenue, south of West Clarke Street, in the 15<sup>th</sup> Aldermanic District.

The subject site, 2560 N. Teutonia Avenue, has been vacant since around 1980 and was acquired by the City of Milwaukee in 2001. The adjacent homeowner to the south, Tyrone Tubbs, intends to purchase the subject site from the City of Milwaukee and combine it with his residential lot for use as additional greenspace within his yard. Since the subject site is zoned LB2 and Mr. Tubbs' site is zoned RT4, a zoning change is necessary before the two sites can be combined. Please refer to the reverse side of this notice for map details.
