I am forwarding to your attention a claim received by the City of Milwaukee from Ezzard White, who alleges damage to his 1994 Oldsmobile. Mr. White alleges that when he picked up his vehicle from the tow lot on June 5, 2002, he discovered a slash in his right tire.

According to Louis Black at the City of Milwaukee Tow Lot, The PT-27 does not indicate damage to the front tire, but the videotape shows that upon arrival at the tow lot, the vehicle had a flat right front tire. It appears the damage occurred during the towing of the vehicle and we are therefore tendering this claim to you.

If we do not hear that this matter has been resolved in 30 days, we will tender the claim to your insurance carrier.
