I am writing to appeal your decision of the city not being liable for damages to my vehicle on September 09, 2022. I am requesting a hearing please.

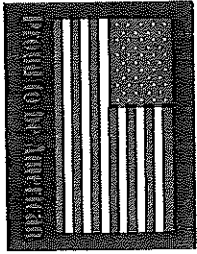

Dear Ms. Burris:

We are in receipt of your claim for damages sustained to your vehicle, on September 9, 2022, in the amount of \$2,956.17, when your 2002 Cadillac Escalade struck a pothole at or near 4780 N. 42<sup>nd</sup> Street.

Our investigation revealed that the Infrastructure Services Division conducted a search of their call center records between 4100-4300 W. Hampton Avenue between the 4700-4900 blocks of N. 42<sup>nd</sup> Street from June 9, 2022 through September 9, 2022. There was one call was received on July 24, 2022, for the location at 4844 N. 42<sup>nd</sup> Street, and the hazard was repaired on July 28, 2022, within a reasonable timeframe.

The City is not liable for damages and we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
