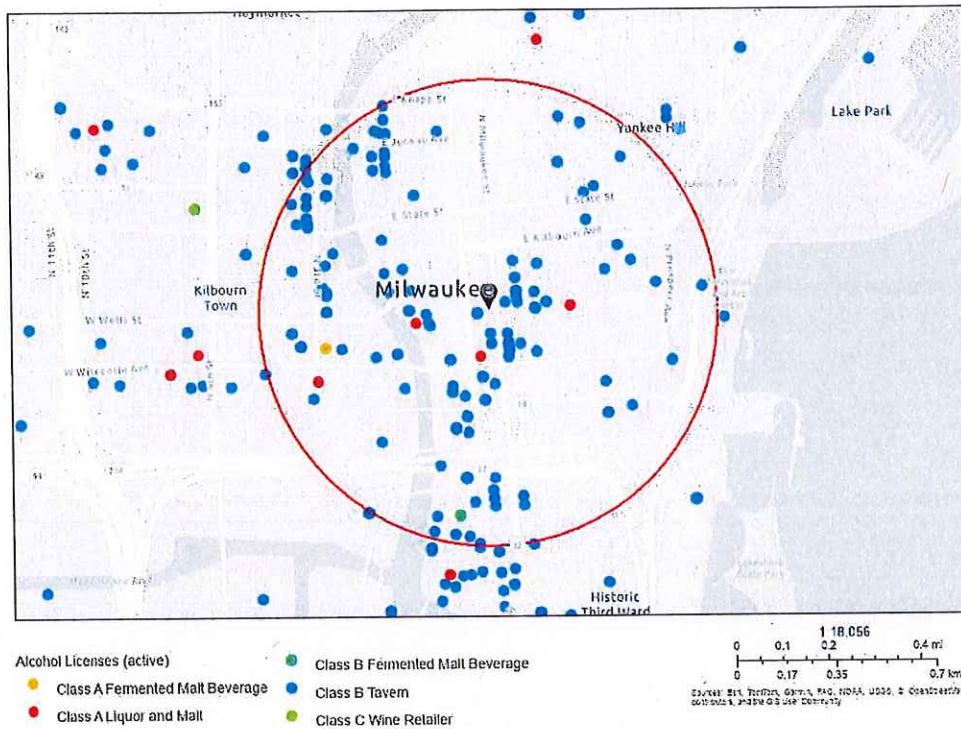


Concentration Map for 763 N Milwaukee St
