Projects for 2659 N Lake Drive

1. Repair and paint wood trim around windows. Work is being done by Community Building & Restoration who specialize in this type of repair. All wood replaced matches existing wood with no changes. Color of paint (White) matches existing paint. Photo #1 indicates work that needed to be repaired and photo#2 shows finished work.
2. Replace exiting drive way with new one. The concrete driveway was in disrepair and needed to be replaced. Tony Lalicata concrete, in business since 1965, was hired to do the work matching the concrete and color to the existing old driveway and matching all drives on the block. Photo #3 the before drive and photo #4 the new drive.
3. Replace dead and diseased bushes in front of the property with new smaller bushes to accentuate the property. The new bushes will not exceed the bottom height of the lower windows.
