Explanations of the following PA33/CAD reports attributed to SkyBox Sports Bar dating back to December 11, 2019. The following number system correlates to the numbers used in the report submitted to the Owner/Agent, Toi Lisa Mark.

4. License check conducted by police and documented. No issues found.
5. License check prompted by an email. The business was closed to dine-in orders and was only operating under a carry-out/to-go system. Recently, an Uber driver was upset because she was asked to sit in her car and/or socially distance outside until her order was ready. It should be noted that the business was closed to dine-in options at the time of this license/premise check and the officers there are aware that looking at our cameras for verification is always an option.
On the next day, a status call to the Alderwoman's office was made to ensure open communication about activities at the bar.
6. The call made to the police was by the manager-on-duty at SkyBox. Please note that the PA33 report was redacted to reflect that there was NOT 3-4 subjects with guns, instead the manager stated that she went to the door, saw a gun, and was advised to keep the door to the establishment locked.

Prior to the call made to the police for help, a female entered the establishment through an unauthorized entrance located at the rear of the building. Patrons attempting to enter through this door negate our set security precaution measures set-up at our front entrance and ultimately this behavior poses a danger to everyone in the establishment. An employee promptly noticed this security-breach/invasion and immediately notified security who then approached the female to escort her out of the building. The female began to shout obscenities at security while refusing to leave the premises. Although the female was verbally stating her refusal to leave she was walking towards the door. As she walked towards the door, she experienced a personal malfunction (loss of wig) which caused her to become more irritated. The female then began attempts to physically fight security and the manager; however, she was escorted out of the establishment where she began to call others to come up to the bar to cause additional harm. Once the father of the individual/female arrived, the manager (Royce Lockett) spoke with the father and the female and her father left the business premises. At this time we closed the bar for the evening.

More importantly, the setting (time and place) of this report must be called to our attention. In saying this, Milwaukee as well as other cities across the nation saw Black Lives Matter protests emerging throughout the city. July 5, 2020 was a day/night of protest. As you can see, the report reflects that there were other activities going on outside of the bar which stopped the police from engaging with the crowd.

After this incident, I, Toi Lisa Mark, set up a meeting with the Capt. D. Feldmeier, Officer Rebro (Community Liaison), and the Safe and Sound Coordinator for our area to discuss concerns for both SkyBox Sports Bar and District #5. The meeting was held and final letter detailing next steps for both entities was created and submitted to Alderwoman Coggs' office, the Department of Neighborhood Services, and District #5. **(Letter submitted detailing our discussed next steps is in this packet)**

7. As the report reflects, an incident occurred and we immediately closed the bar; however, there was traffic coming from/going to the downtown area/Brady street. Moreover the incident which led officers to use O.C. spray involved individuals who were never in SkyBox Sports nor were they ever in the line to enter SkyBox Sports Bar. The ladies involved in this incident, driving in the area, exited their cars on Garfield, and engaged in a physical altercation. It is never our intent to see anyone arrested; however, it was appreciated that the officers worked with the business to extinguish this incident and arrest those involved.

NOTE: This report does show that as a business we are actively/positively working with District #5 to curb parking and other issues. Additionally, we are beginning our research into looking at getting city resources through 'CODE-RED' funding.

8. License check conducted by police and documented. No issues found.

9. License check conducted by police found area of miscommunication. Management was under the impression that the provisional was approved; however, business operations immediately shut down and the establishment was cleared.

10. More discussion relative to the license; however, the bar was found to be closed.

11. Initial call was regarding capacity issues. Responding officer spoke with Royce Lockett who'd just arrived noted the issue as well, spoke with the officers, and began to close the bar for the evening. Immediately closing the bar was a management decision as those responsible for carrying out our initial COVID procedures had failed.

12. The manager-on-duty called for police assistance. When police arrived, the physical altercation was over and those involved had left the premises. Also at the time of their arrival the bar was closed.

13. On the following Monday, the bar was close down an internal investigation relative to the incident that occurred the night before. As the owner, I was able to take time to review footage from various angles in the bar. I was also able to see what took place prior to the unnecessary altercation.

In summary, Group A (4 ladies) and Group B (4 ladies) were initially enjoying the evening together. One lady from group A began to argue with another lady in group B. The verbal altercation instantly grew intense and a physical altercation ensued. Security responded and unknowingly took 3 of the 4 girls in Group A out of the back entrance of the bar and escorted them to their car. Other security personnel unknowingly took the 4 females in Group B plus the remaining female from Group A out of the front. As security was attempting to get them to their car, the females from Group B began to fight again and jumped the one female from group A. When the females in Group A noticed that their friend was not with them, they drove around to the front of the bar, saw what was happening, and got out of the car and again engaged in physical violence.

Security was able to extinguish the fight. All parties left the premises prior to the police arriving at the scene. Once I'd captured all the information that I needed to move forward, began taking action.

14. As the owner of the business, I contacted Dist. #5 to speak with them about changes in light of the incident that occurred on 2/28.

The following are the steps taken/implemented to proactively prevent/discourage any recurrence.

- Immediate removal of the security team as their direct and blatant disregard for our COVID Safety Plan placed the business, patrons and the community at-risk.
- Hired new security team (TSS Security) w/enhanced an scanning system
- Formal introduction of security team to Tavern Squad Officers
- Immediate removal of all promoters (Until security team is in place and familiar with business and COVID procedures)
- Early weekend closures/reduced hours (Until security team is familiar with business and COVID procedures)
- No Trespassing Orders sent to last known address found on CCAP for ALL parties involved (Total 10)
- Organized 14 bars throughout the city and instituted an Across-the-Bars BAN list of individuals who blatantly disregard an establishment's code of conduct. Issues/Individuals of this nature should not be allowed to move to another establishment/district and possibly cause other unwarranted disturbances.
- Capacity reduced to 50%
- All Staff (including security) meeting to reiterate COVID Safety Plan, expectations, and consequences for failure to follow non-negotiable directives.
- Additional management added to team
- Monday check-in (email) with Alderwoman's office to inform of any incidents. To date there are none to report.

- Regular check-in's with Officer Rebro (District #5) Community Liaison Officer

15. Police came to SkyBox to retrieve video footage of the incident that occurred on 2/28. Here we find the narrative associated with the video footage willingly given to the tavern squad.

On July 13th, I received a letter from your office detailing the possibility of my business, SkyBox Sports Bar, located at 2213 North MLK Drive could be considered a nuisance. After briefly speaking with you on the phone, we were able to promptly set up a face-to-face meeting. This meeting revealed various issues as we all took the time to review police reports, discuss inconsistencies, and outline our concerns. Additionally, we were able to discuss other issues on both sides of the fence as well as develop a plan of action.

As we move forward during this unprecedented time, Skybox Sports Bar is committed to working with the Milwaukee Police Department (specifically District 5, but we will work with all departments as needed), your office (Community Affairs/Safe and Sound), and the residents of Milwaukee. In saying that, the Milwaukee Police Department can expect and guarantee that SkyBox Sports Bar will:

1. Pay for and ensure that a security car is staffed and parked in the parking lot near/next to SkyBox Sports Bar to ensure that physical safety of our patrons as they commute to and from their vehicles into SkyBox Sports Bar.
2. Pay for and ensure that a different security car is staffed and travels east and west on Garfield and MLK. This car will also travel North and South on 4th street and MLK.

3. Pay for and ensure that a licensed, bonded and secured security company will provide no less than 6 armed security guards (CCW's will be verified and on file in house) on the weekends (Friday, Saturday and Sunday) to not only provide additional safety and security, but to also provide additional security to our patrons inside of SkyBox Sports Bar.
4. Utilize ID scanners to verify the patron's age and identity of each person patronizing the bar.
5. Adhere to all CDC and the Milwaukee Department of Health guidelines and standards. This does include having a copy of the approved risk management plan, enforcing face masks/coverings, and monitoring capacity limitations as our license and/or the City of Milwaukee states.
6. Continue to actively connect and engage in the Halyard Park Community Association. My commitment will be to attend community meetings and address any community issues relative to SkyBox Sports Bar. This commitment will look like a partnership that works for and towards the well-being of the Halyard Park residents and the citizens who patronize SkyBox Sports Bar.
7. Continue my commitment and participation in Milwaukee's Business Improvement District (BID). This, too, will look like a partnership where we will work together for the betterment of the community.
8. Post '**No Loitering**' signs on and near the premises of SkyBox Sports Bar. In addition to the signs, security will reinforce this expectation.

It should be noted that these are our immediate commitments to the Milwaukee Police Department/Community, but we are open to discussing any additional improvement-based commitments as the need arises.

Just as there are expectations of me as the owner of SkyBox Sports Bar, I, too have expectations of the Milwaukee Police Department. These immediate expectations include, but are not limited to:

1. Having any and all police reports to accurately document the correct address of an incident. This means that the address attached to SkyBox Sports Bar (2213 North MLK Drive) will NOT be arbitrarily used simply because we are the only open business or because an individual came to our establishment for assistance.

2. Having District 5 police officers patrol the area and/or have a visible presence. This will not only help SkyBox Sports Bar, but I'm sure the residents of Halyard Park will appreciate this visible presence.
3. The police department recognizing and knowing that SkyBox Sports Bar, as well as other establishments in the area close at 2:00 am will assist with clearing the area during this time frame (1:00 am – 3:00 am) on the weekends.
4. It is understood that there are more patrons than officers. With that understanding, it is the expectation of SkyBox Sports Bar that should the police officer deem it unsafe for the officer and/or their partner to exit their vehicle, they will at the very least make their presence known by either, shining a bright light on the focused area and/or turning on the emergency lights with or without the siren.
5. The police officer(s) (especially Tavern Car officers), will work collaboratively and respectfully with the owners and managers of SkyBox Sports Bar to ensure that ALL individuals are safe. Additionally, officer(s) will refrain from demeaning and threatening comments, as these comments do not serve the overall well-being and nature of the business and the community that we both wish to see thrive.

Just as the video footage of that utterly disgusting physical altercation went viral, I, along with other bar owners will make our rules, regulations and expectations known throughout the city of Milwaukee. We, bar owners, will NO longer accept, excuse, and/or tolerate bad behavior that is ultimately detrimental to our business, our community, and our ever growing city. Collectively, we will send an extremely loud and just as viral message to disruptors, fighters, and those who refuse to respect proper codes of conduct. The message is simple ... they will not WIN! Thank you for your time and I look forward to representing Milwaukee's Nightlife and entertainment scene in a positive and prosperous way.

Entry upon private property after being forbidden as trespass; prima facie evidence; penalties; arrest; tenants or occupants excepted.

Section 120. Whoever, without right enters or remains in or upon the dwelling house, buildings, boats or improved or enclosed land, wharf, or pier of another, or enters or remains in a school bus, as defined in section 1 of chapter 90, after having been forbidden so to do by the person who has lawful control of said premises, whether directly or by notice posted thereon, or in violation of a court order pursuant to section thirty-four B of chapter two hundred and eight or section three or four of chapter two hundred and nine A, shall be punished by a fine of not more than one hundred dollars or by imprisonment for not more than thirty days or both such fine and imprisonment. 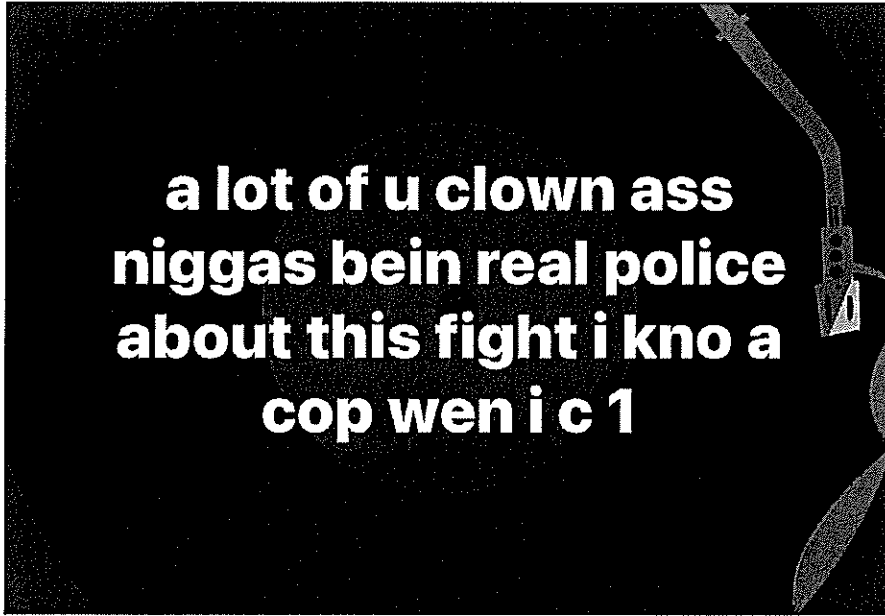

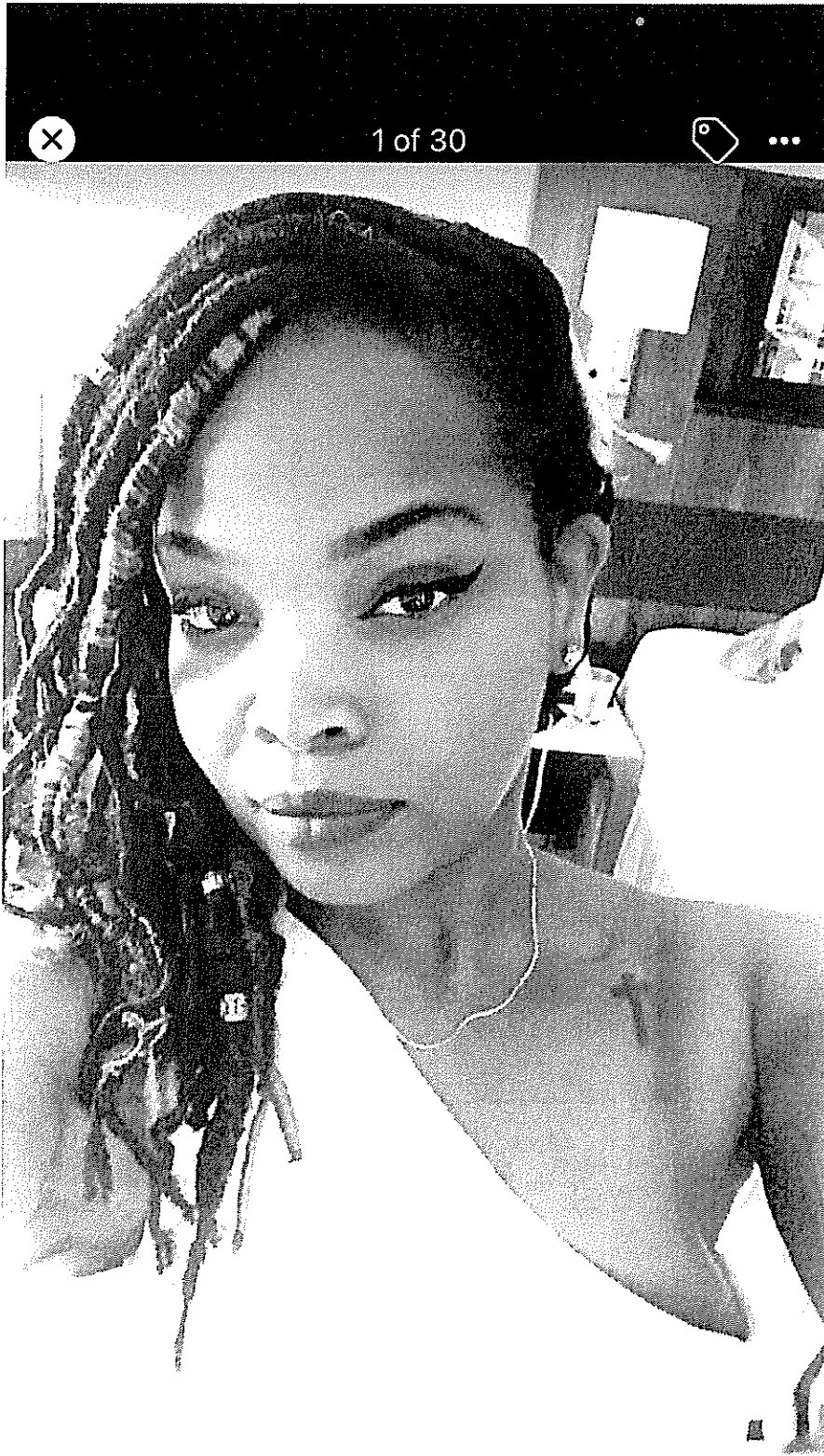

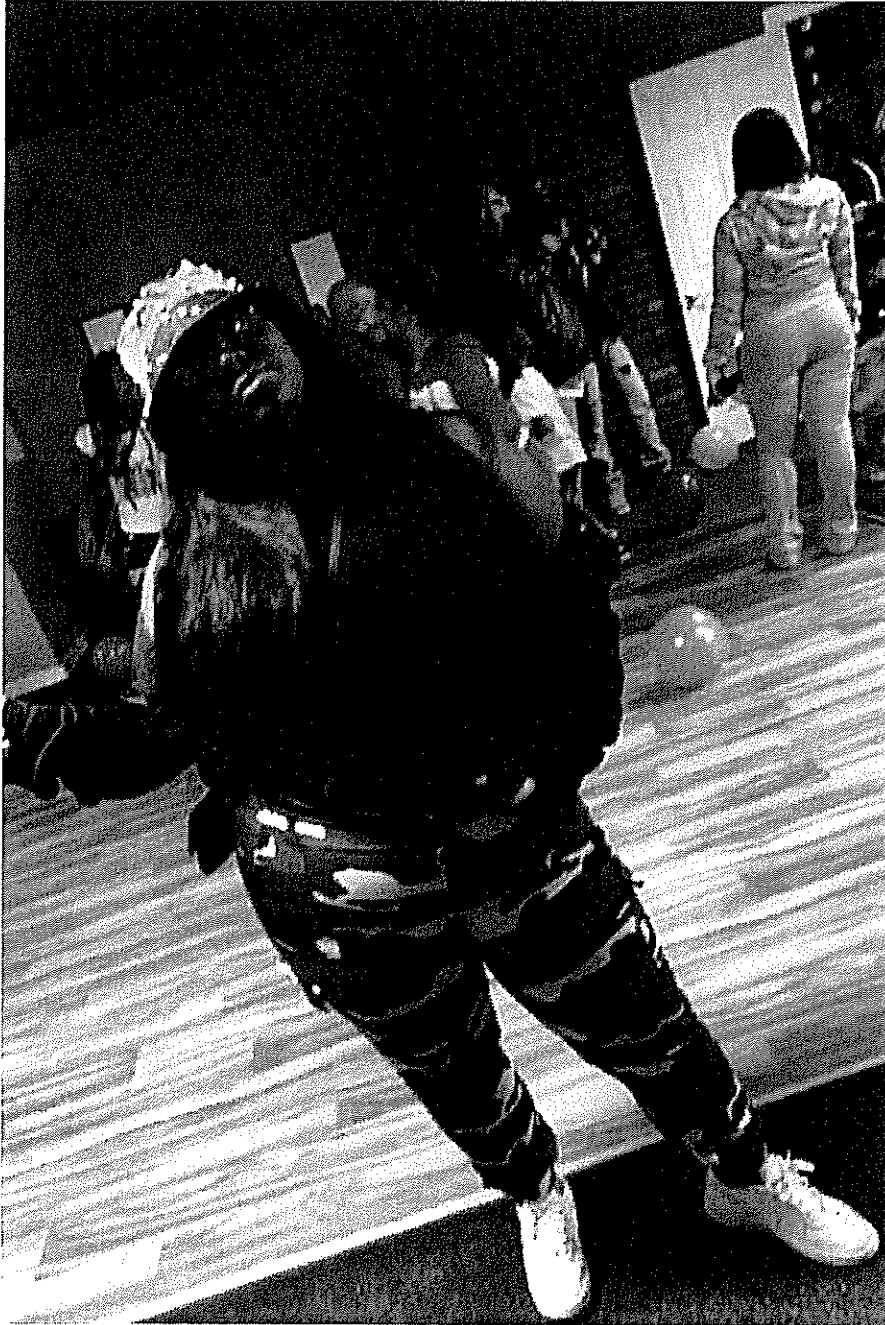

I wanted to follow up and let you know it has been agreed upon within our department that an appeal can be made to reinstate your revoked safety plan should you choose. I know this was a question you had asked on our last call.

Please email us at cehadmin@milwaukee.gov stating the request and your reasoning. We will review it and current plan/compliance issues within *two weeks* and follow up with you on any edits to address areas of concerns that may have been highlighted by previous compliance issues. You will then have an additional *two weeks* to update your plan and submit back to us for final approval. During this time is expected that you continue to operate within the allowances in our current order.

I should add establishments submitting an initial plan will be prioritized by our staff however we are in a pretty good place with these so I do not see there being much delay in the process for those appealing revoked plans at this time.
