This report is written by Police Officer Tracy TABIADON, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 02/06/09 at 1:30 am, Milwaukee police were dispatched to 2936 S 13th Street for a Subject With Gun complaint. Officers spoke to the caller who stated a patron who was still in the tavern was armed with a black semi-automatic handgun. The caller provided a description of the patron and stated this patron had the gun in waistband. Officers entered the tavern and located the subject who matched the description given and recovered the handgun. Further investigation revealed this subject to be under the age of 21 and highly intoxicated. He was also found to be in possession of a half full Heineken beer. This subject was arrested and charged with Reckless Use of A Weapon and issued a citation for Possession/Consumption of Alcohol Underage. On 02/07/09, officers conducted follow up at the tavern and spoke to the bartender Sylvia Lagiewka regarding the violation found. Lagiewka stated she couldn't believe that an underage person would be in the tavern because she had security at the door checking patrons ID's. Lagiewka stated she would further discuss this with her security. Officers then spoke to the licensee Stojan Coralic and explained the violations found. Officers issued a citation to the bartender Sylvia Lagiewka for presence and sale to underage and one to Coralic for Licensee Responsibility.

Y On 01/12/2010, disposition was added to item #1.

2. On 05/09/2009 at 2:20AM, a Milwaukee Police Department squad was sent to a shooting at 2952 S 13th Street. A Detective interviewed the victim as well as a witness who stated he observed the suspect and accomplices inside The Brew House prior to the shooting. The incident occurred outside the tavern.
3. On 09/27/2009 at approximately 1:55AM, Milwaukee Police Department squads were dispatched to a fight at 2936 S 13th Street (The Brew House). Officers spoke to Ricardo D ARTEGA who stated there was an argument between two (2) females where one of the females threw a boot at the other then they left. While the females were walking towards their vehicles, in the street, they were causing a disturbance by yelling obscenities and screaming. Other patrons were in the street in front of The Brew House and across the street impeding traffic and causing vehicles to stop.
4. On 10/03/2009 at 2:15AM, Milwaukee Police Department squad was flagged down for shots fired in the 2900 Block of S 13th Street by several witnesses who stated people were shooting from a maroon Dodge Intrepid at the corner of S 13th Street and W Montana Street. As an officer exited his squad, the driver of the Intrepid accelerated away at a high rate of speed in an attempt to elude officer. The officer pursued the Intrepid until it was involved in an accident. An officer spoke to the front seat passenger who stated they were leaving The Brew House and that somebody had been shooting at them.
Several of the callers and witnesses stated that they heard several people arguing outside The Brew House. The bar patrons were standing in the street, stopping their cars in the street and playing loud music prior to the gun shots. They heard multiple gunshots in the area where patrons from The Brew House were congregating.
5. On 10/11/2009 at 12:20AM, a Milwaukee Police Department Sergeant and officer conducted a tavern check at The Brew House, 2936 S 13th Street. A subject was in the men's restroom that appeared to be under the age of 21. He was asked for identification and he stated he did not have any. Subject was taken outside where he showed his WI ID that showed a birth date of 08/22/1990. Subject stated he was not carded when he entered the tavern. The manager stated that everyone was carded when they entered the tavern. Citation was issued to Stojan CORALIC for:
