On 02/19/23 at 8:49pm, Milwaukee Police were dispatched to shooting complaint at 3039 N. 12<sup>th</sup> St. Officers spoke with the victims who stated that he and his friend were at the gas station and the suspect fired gun shots at them. The victim had a gun shot wound to the shoulder. Officers conducted follow up at the business 3000 N. Teutonia Av, the occurrence of the shooting. The business was cooperative with the investigation and provided video. The video depicted the victims, the suspect and the suspect vehicle prior to the incident. The video also showed the victims exit the gas station and a subject from the suspect vehicle discharged a firearm in their direction multiple times. All parties involved fled the location. *Further investigation revealed the shooting took place at the store next to the gas station.*
6. On 03/13/23 at 1:29pm, Milwaukee Police conducted a business check at 3000 N. Teutonia Av,. Officers were accompanied by a DNS Inspector. During the check the DNS Inspector asked for the occupancy permit and food license which were not displayed in the business. Communication with the owner was attempted regarding the location of the licensees which were not displayed, and it was claimed taking by police during the incident on 02/19/23. The employee was unable to help with the matter and officers were told that the agent would be in at 3:00pm. The DNS Inspector and officers continued their check but the officers were able return on the same date at 2:33pm, and spoke with a different cashier regarding the missing licenses. The current cashier also was not aware of the location of the missing licenses. The outcome of the check was a seven day order to produce the not displayed licenses, by the DNS Inspector.

This report is written by James TERRELL, assigned to District Five Late Power Shift, squad 5468 with PO Nora BURLO.

On 02-19-2023, at approximately 8:49 PM, officers were dispatched to a Shooting located at 3039 N. 12th St, which is located in the City and County of Milwaukee.

Upon arrival, officers observed the victim who was identified as Lamar L. BAKER (B/M 04-15-2007) with a GSW to the left shoulder. Also on scene was a witness who was identified as Lamarious J. SIMS (B/M 05-07-07).

BAKER stated that he and SIMS were at a gas station located at 3000 N. Teutonia Av. BAKER stated that he and SIMS were exiting the gas station when SIMS stated to BAKER "Is you trying to go to the gas station" BAKER stated that the suspect who he described as a B/M light skin complexion, approximately 20 years old, 6'01 feet tall, with long black dreadlocks, wearing a black hooded sweatshirt, black pants, and black timberland boots heard SIMS and thought he was talking to him. The suspect stated, "What did you say" and proceeded to get out of a vehicle which was described as a Black Chevrolet Malibu and shoot towards the victim. BAKER and SIMS ran to BAKER'S house which is located at 3039 N. 12th St. where they then called police. BAKER has been transported to Children's Hospital.

A ShotSpotter Activation was associated with this shooting Flex ID # 81-904562 for 7 rounds in the street and Flex ID # 81-904563 for 1 round in the street.

PO BURLO and I, viewed surveillance footage at 3000 N Teutonia Ave. The footage showed two teen subjects walking W/B on W Chambers St towards the location and enter into the premise. A black vehicle parked on W Chambers St next to the location shortly after. A (B/M) subject with a long dreadlock's hairstyle wearing dark clothing exited the rear passenger door of the vehicle and entered

inside of the premise. Shortly after the three subjects exited the premise, the B/M subject with dreadlocks reentered back inside of the vehicle as the two teen subjects began walking S/B on N Teutonia Ave. The subjects are seen briefly looking towards each other. Suddenly an unknown subject wearing a red top exited the driver side door of the black vehicle and began discharging a firearm multiple towards the teen subjects as the fled on foot.

The employee of the location identified as Terrall JACOBS (M/B, DOB 09/22/1988) and manager identified as Randolph HARVEY (M/B, DOB 04/15/1972) were cooperative in this investigation. This incident did not occur inside of the premise.

This report is being written by PO Stephen COLWELL, assigned to District Five, Early Power Shift, Squad 5266.

On Monday, March 13th, 2023, at 2:33 PM, I conducted a Business Check at Kali Cornerstore LLC, located at 3000 N Teutonia Ave, City and County of Milwaukee. Kali Cornerstore LLC is a licensed premise within the City of Milwaukee and currently holds active licenses for Cigarette & Tobacco and Food Dealer Retail, which both expire on 11/15/23. The licensing agent for this licensed premise is Katelyn J WILKES (B/F, 8/28/1990).

Prior to this business check, PO Christopher SCHLEI in Squad 5264 and I conducted an inspection of this business along with Department of Neighborhood Services Inspector Matthew RZEPKOWSKI. This initial inspection occurred at 1:29 PM, 3/13/23. (See CAD #230720638) During this inspection, Insp RZEPKOWSKI asked the cashier about the location of the occupancy permit and food license and asked why there were not posted and visible. The unidentified female cashier stated she only works the register and as not able to assist us or provide additional information. Posted next to the cashier window was a Cigarette & Tobacco License which had a 2022 expiration date. (CIG-1030710)

Also on scene was an unidentified male subject who did not work at the store but stated he could call the owner. The unknown male subject called the owner and informed us the owner stated he would come into the store at 3:00 PM to meet with us. We explained we would not be able to return later, and that the inspection of the business was occurring now. Insp RZEPKOWSKI requested the owner to tell him over the phone where the occupancy permit was located. The unidentified male subject appeared to become irritated and would not assist us any further in communicating with the owner. The unidentified male relayed to us that the owner was claiming police officers took possession of the permit when they investigated a shooting that occurred at the location on 2/19/2023. (IR: 230501389) PO SCHLEI and I then continued with prescheduled inspections throughout District Five.

I returned to the business at 2:33 PM to determine if the occupancy permit had been located. Upon my arrival, I spoke to the cashier on duty who identified himself as Terral D JACOBS (B/M, 9/22/1988). JACOBS had not been working during my previous assignment at the store. JACOBS stated that he too did not know where the occupancy permit or food license was located. JACOBS identified to store manager as "Ray Harvey", later discovered to be Raymond S HARVEY (B/M, 4/29/1969), and stated Ray would be at the store later in the day.

The interior and exterior of the store was clean and clear of excess trash. Insp RZEPKOWSKI stated he would be placing a seven-day order on the business to produce the appropriate documentation prior to taking any additional actions.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
