On Sunday, April 7th, 2019 at approximately 4:16 AM, Squad 2330 (PO Christian SANCHEZ-ALCANTAR and I, Yariceliz Ramos-Vazquez) were dispatched to a Battery complaint that occurred at the location of 1619 S 1st St, which is in the City and County of Milwaukee.

The victim, [REDACTED] (w/f, 05/27/88), went to the District Two Station to report the incident and then went to St. Luke's Hospital to receive treatment for her injuries.

De. [REDACTED] IS stated that she has had a "quarrel" with the suspect, [REDACTED] (w/f, 09/22/89), that has lasted years because they had once shared the same "baby daddy". De. [REDACTED] S stated that she hadn't seen [REDACTED] Z in over a year, but because of the "bad blood" that they've had, as soon as they saw each other today inside the Pointe View Bar, they immediately engaged in a physical altercation. Parties were separated by friends and "went on their way". De. [REDACTED] S stated that when she exited the bar at 2:30 AM, she saw that [REDACTED] Z was waiting for her standing on the South side of the building. DeJesus stated that [REDACTED] Z was hiding her right hand behind her and thought it was going to be "round two" of fighting when [REDACTED] Z lifted a glass bottle and hit D [REDACTED] JS on the upper right side of her head near her forehead. The bottle broke with the impact, causing several cuts on DeJESUS' face. I observed a bump on the right side of D. [REDACTED] JS' forehead near the hairline that was turning purple along with several small cuts that looked like scratches near the area of the bump on the right side of [REDACTED] S' forehead. I also observed a 3-4 inch laceration on l [REDACTED] JS' right cheek that began near the right eye and ended approximately 1/2 inch away from the corner of the mouth. S stated that the business' security were on scene and observed the incident happen. According to L [REDACTED], as soon as she was injured, Pointe View Security escorted her to her vehicle. [REDACTED] did not see in which direction [REDACTED] Z went. [REDACTED] went home and called a friend, who later brought her to District Two Station to file a complaint.

DeJESUS was admitted at 3:45 AM to Aurora St. Luke's Hospital and treated by Dr. HIBERT. DeJESUS received 10 stitches on her laceration.

DeJESUS was ordered in on Monday, April 8th, 2019 at 8:30 Am to the District Attorney's Office. PV-17 was issued.

PO SANCHEZ-ALCANTAR and I attempted to locate [REDACTED] at her listed address but there was no answer on the door. A suspect alert and felony want was submitted for [REDACTED] Teletype MWPD-23.

At approximately 6:00 AM Acting Lieutenant SMOLEN was notified of the incident and stated it was ours to handle.

This case is pending to be reviewed by DA on 4/8/19 at 8:30 AM.
