This report is written by P.O. Mark WOOD, assigned to District 5, Early Shift, Squad 5231.

On Monday, July 3, 2023, at 5:45 PM, I was dispatched to 3004 N 12th St, located in the City and County of Milwaukee, for a shooting complaint.

Upon our arrival I observed a corner store by the name of NORTH SIDE MEAT MARKET at the address of 3004 N 12th ST. Upon entering the story, I observed a male subject laying in the aisle on the north end of the store with a GSW to the head, laying in a pool of blood. 5290, 5215, 5231, 5242, 5214, 5264, 5266, 9218, 9231, 9235, 9226, 5222, 9233, 1822, 9214, 5215, 1822, 5468, 9228, 9237, 5210, 5410,

I spoke to the caller, Nathaniel SMITH (B/M 3/28/1981) (414) 264-4526. SMITH is the manager for the meat market. The victim walked past the suspect, when the suspect shot the victim point blank. The victim sustained 4 gunshot wounds. SMITH stated the suspect rose from the ice cream cooler and fired shots at the victim. The suspect was in the store, and the victim entered the store. The victim walked into the location where the suspect was sitting in the location waiving a black gun, possibly a revolver.

The business was cooperative with the investigation.

The business had 0 security officers on scene.

I reviewed video surveillance footage. The footage showed the suspect to be in the store and sitting in the northwest corner of the store sitting on an ice cream cooler. The victim walked into the store and walked to the far north aisle. The victim walked past the subject heading eastbound down the aisle, the suspect then got up off the ice cream cooler and shot the victim point blank. The suspect then fled the store on foot. The video was recovered and uploaded and inventoried by C.I.B. to AXON. SMITH was able to provide immediate access to the security footage and was able to assist in viewing the footage.

While on scene, I observed the licenses posted and they were up to date. During my investigation for shooting I did not observe any violations in the licensed premise.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
