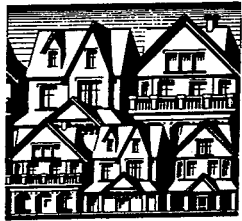

Dear Royal:

Greetings, I hope you continue to be well and look younger every day with that restrictive diet your daughter makes sure you follow.

Two important subjects I am compelled to write you about. Enclosed is a copy of the police computer print out for the recent dispatches to 2720 West Kilbourn Avenue. It shows an inordinate amount of difficulties that seems to indicate a lack of tenant screening and proper management. Personally, I witness a lot of loitering on the front porch and by the side parking area. At a recent neighborhood meeting of the police and residential property owners 2720 was also identified as a stop on the route of the street drug dealers we're all committed to eradicate, including those who parade on the Kilbourn side and in front of Shop N' Save.

As the license renewal time approaches we'll see if the problems have stopped or whether there ought to be a hearing. Therefore, it does seem the right time to resurrect the idea of your donating the cleared property to the YWCA, keeping some for employee parking for Shop N' Save, and having Barry Mandel and the YW Develop the property as a play area for their tenants' children. I hope you will talk to Barry as soon as possible. I have spoken to him about this recently and he is expecting to get back on the subject. As we talked about this several years ago it would seem to me this all could be accomplished before the snow flies.

As for Shop N' Save, I really have to ask you to put some capital into exterior improvements. The aesthetics are terrible but especially exterior lighting on the Kilbourn and back sides at night are needed to "expose" the loiterers. A video camera on the Kilbourn side is necessary because there are no windows. The police can monitor the activity from inside and when they see "deals" make immediate arrests. They can even review tapes of the videos and do warrant checks and look for probation and parole violators. Architect Jim Pinoni did a great design and cost estimate for a new façade treatment for Adman Ahmed (Dany); office 263-5020 or 963-4946 or home 962-2965.

I know you always sign a triple net lease but in this case I would really hope you can reinvest substantially, because, as you know, the building has not seen any work in many years. Attorney Jennifer L. Havas representing the new tenants, spoke with Gary about this in April and he agreed there is "room for improvement of the exterior" and gave her "assurance" that he would be willing to participate in the necessary upgrade. The city also has "façade grant" monies available in a modest amount. It is now August, nothing has been done, but I hope we can accomplish the project this season. We have 3 or 4 hot irons in the fire to improve 27th Street. In my judgment, you should show the way. You know the score. Let's all be winners.

I'll be in the hospital next week for my knee replacement so after you or your staff talk to Mandel and /or the YW and Pinoni I hope you will get back to me.

Thank you, Royal.
