FINDINGS OF FACT

1. Shannon N. Jones (hereinafter the "Licensee") is the holder of a Class "D" Bartender License in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, December 31, 2008.
2. An application to renew said license was untimely filed with the Office of the City Clerk on September 11, 2009.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On September 14, 2009, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
4. On September 16, 2009, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on September 29, 2009, commencing at 1:30 p.m. in Room 301B of City Hall. At said date, time and place, the licensee did not appear.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

A. A notice of the hearing as well as a copy of the police report was sent to Shannon N. Jones at 6563 North Bourbon Street, Milwaukee, Wisconsin 53224 on September 16, 2009 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 6563 North Bourbon Street, Milwaukee, Wisconsin 53224 is the address given by the Licensee on her application. The envelope was not returned to the License Division by the United States Postal Service. The Licensee failed to appear at the hearing on September 29, 2009.


CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based on the above facts found, the Committee concludes that the Licensee, Shannon N. Jones, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender license based upon nonappearance.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Class "D" Bartender license held by Shannon N. Jones based upon nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes, zero (0) noes and one (1) excused, recommends that the Class "D" Bartender License be denied based upon nonappearance.

On February 3, 2009, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
4. On September 16, 2009, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on September 29, 2009, commencing at 1:30 p.m. in Room 301B of City Hall. At said date, time and place, the licensee did not appear.


CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based on the above facts found, the Committee concludes that the Licensee, Erica L. Perry, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender license based upon nonappearance.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Class "D" Bartender license held by Erica L. Perry based upon nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes, recommends that the Class "D" Bartender License be denied based upon nonappearance.

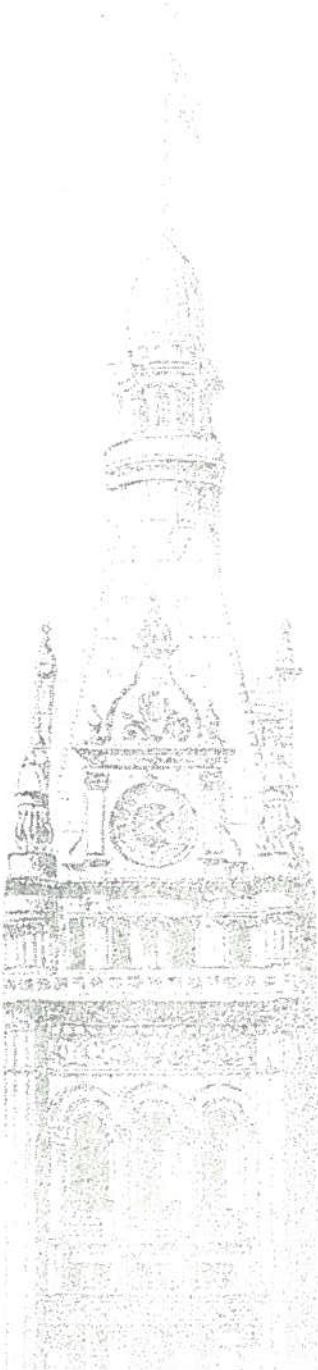

Re: Report of the Renewal Application of Robert Griffin, for a Home Improvement Contractor license.

FINDINGS OF FACT

1. Robert Griffin (hereinafter "Licensee") is the holder of a Home Improvement Contractor license in the City and County of Milwaukee, Wisconsin. Said license expired at midnight on February 28, 2009.
2. An untimely application to renew said license was filed with the Office of the City Clerk on September 1, 2009.
3. Pursuant to Chapter 95 of the Milwaukee Code of Ordinances, the matter was referred to the Milwaukee Police Department for investigation. There was a Milwaukee Police Department report that could form the basis of non-renewal or suspension of this license dated September 2, 2009. There were objections to the granting of such a license due to the operation as a Home Improvement Contractor in the City of Milwaukee without the required licenses; alleged violation of and prohibited practices of the Milwaukee Code of Ordinances § 95-14; the applicant's failure to act in accordance with MCO § 95-14; the inability of the applicant to substantially understand the required business regulations set forth in MCO § 95-14; that the applicant has been issued a warning letter or had the imposition of administrative sanctions by the Wisconsin department of agriculture, trade and consumer protection; and that a judgment has been rendered against the applicant by a court of competent jurisdiction regarding violations of ordinances of the city or laws of the state of Wisconsin, the nature of which substantially relate to the particular activity for which the license is issued; that a judgment has been rendered against the applicant regarding improper work,



and other factors which relate to the health, safety and welfare of the public. There was also a warning letter from the State of Wisconsin Department of Agriculture, Trade and Consumer Protection dated January 7, 2008 with an attached complaint of Lois L. Sneed.

4. On September 17, 2009, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 95 of the Milwaukee Code of Ordinances, of the police report that could form the basis for suspension or non-renewal of the license of the Licensee. The matter was scheduled for a hearing on September 17, 2009 at 1:45 p.m. in Room 301B of the third floor of City Hall. At said date, time and place, the licensee did appear and was not represented by counsel.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On January 30, 2004, the licensee was issued a citation in the City of Milwaukee for lead clearance standards. The licensee was found guilty on this charge on March 29, 2004 and fined \$160.00.
 - B. On August 6, 2007 at 3:00 p.m., the licensee was issued a citation in the City of Milwaukee for certification of worker/employee required and was found guilty of this citation on September 13, 2007 and fined \$160.00.
 - C. On August 6, 2007 at 3:00 p.m., the licensee was issued a citation in the City of Milwaukee for interior preparation and was found guilty of this citation on September 13, 2007 and fined \$240.00.
 - D. On June 19, 2008 at 8:30 a.m., the licensee was issued a citation in the City of Milwaukee for certification of worker/employee required and found guilty of this citation on August 7, 2008 and fined \$160.00.
 - E. On September 8, 2008 at 4:00 p.m., the licensee was issued a citation in the City of Milwaukee for certification of worker/employee required and found guilty of this citation on February 12, 2009 and fined \$100.00. This item has resulted in an open arrest warrant for the licensee. A letter was sent to the licensee on September 2, 2009.

F. There was also an objection from Ms. Lois Sneed to the renewal of this license. According to information received into the record, Ms. Sneed contracted the license applicant to repair a porch at her home at 2820 North 22nd Street in the City and County of Milwaukee, Wisconsin in approximately September of 2007. The records of the City of Milwaukee demonstrate that no building permit was applied for until October 2007. Ms. Sneed was so upset with the work that she commenced a small claims action against the licensee which resulted in a final judgment in the amount of \$632.50 on May 4, 2009.

G. On January 7, 2008, the licensee was issued a warning letter by the Wisconsin Department of Agriculture, Trade and Consumer Protection Division regarding violations of ATCP §§110.05 (2) (d), 110.02 (6) (l), and 110.02 (11), future violations of which could result in civil and/or criminal prosecution.

CONCLUSIONS OF LAW


1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 95-14 of the Milwaukee Code of Ordinances. Specifically the criteria of Section 95-14-7-c-1-a through -h requires the Licenses Committee and the Milwaukee Common Council to consider violations of law including municipal ordinances relative to the work of a home improvement contractor, whether the Department of Agriculture has issued warnings regarding the work and activities of a home improvement contractor, and whether or not the home improvement contractor has had judgments rendered against him, her, or it regarding law violations or improper work as a basis for possible non-renewal of the operating license of a home improvement contractor. This licensee has met all of those considerations regarding possible non-renewal of this license.
2. Based upon the above facts found, the Committee concludes that the licensee, Robert Griffin, has not met the criteria of Chapter 95-14 of the Milwaukee Code of Ordinances to allow renewal of his Home Improvement Contractor license based upon the police report, citizen objection, warning issued by the Wisconsin Department of Agriculture, Trade and Consumer Protection, and a final judgment of the Circuit Court of Milwaukee County as a result of improper work. The Committee finds the police report, warnings issued by the Wisconsin Department of Agriculture, Trade and Consumer Protection Division and the Circuit Court judgment to be true.

3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Home Improvement Contractor license of Robert Griffin.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes, zero (0) noes and one (1) excused, recommends that the Home Improvement Contractor license held by Robert Griffin not be renewed based upon the police report, warnings by the Wisconsin Department of Agriculture, Trade and Consumer Protection Division and adverse judgment issued by the Circuit Court of Milwaukee County.


