This office is in receipt of your claim in the amount of \$2,865.00, relating to damage sustained to your vehicle on November 24, 2001 when it was hit by a Milwaukee Police Department vehicle at the intersection of North Pierce Street and East Wright Street.

Our investigation reveals that the Wisconsin Motor Vehicle Accident Report completed as a result of this accident notes that another vehicle had gone through the stop sign. The police vehicle swerved to avoid a collision and hit your parked vehicle. The other vehicle then fled. The primary liability for this accident is on the other vehicle. We have evaluated the liability on the police vehicle to be 30 percent. Our independent appraiser has evaluated your vehicle to be worth \$1,940.00. Pursuant to the February 18, 2002 conversation you had with our office, the City of Milwaukee is prepared to offer you \$582.00, which is 30 percent of our evaluation. As such, the City of Milwaukee proposes to settle this claim for \$582.00.
