### **DEAR PERSON OF INTEREST:**

The Common Council has referred File No. 220877 to the City Plan Commission (CPC) for recommendation. This file relates to the change in zoning from Industrial Light, IL2, to Local Business, LB2, to allow mixed-use development on the property located at 3808 West Wisconsin Avenue, on the north side of West Wisconsin Avenue, east of North 39th Street, in the 15th Aldermanic District.

The owner of the subject site, TEAM Management, and Wisconsin Redevelopment are partnering to create a mixed-use development on the site. Plans include redeveloping an existing residential building on the north portion of the site, and constructing a new, mixed-use building along Wisconsin Avenue. On-site parking will be provided for the residents and commercial tenants. A change in zoning to LB2 will allow mix of uses that are proposed. **Please refer to the reverse side of this notice for map details.**
