3rd Aldermanic District

Alley between E. Center St., E. Hadley St., N. Humboldt Blvd., and N. Weil St. (ST212060103):

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where necessary.

7th Aldermanic District

N. 29th St. – W. Melvina St. to W. Capitol Dr. (ST21110118):

Asphalt pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, and grading.

Alley between W. Auer Ave., W. Concordia Ave., N. Sherman Blvd, and N. 44th St. (Northerly 225 feet m/l) (ST212060115):

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where necessary.

8th Aldermanic District

Alley between W. Cleveland Ave., W. Montana St., S. 49th St., and S. 50th St. (ST212060106):

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary.

Alley between W. Forest Home Ave., W. Manitoba St., S. 40th St., and S. 41st St. (ST212060118):

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary.

10th Aldermanic District

Alley between W. Dixon St., W. Stevenson St., S. 73rd St., and S. 74th St. (ST212060124):

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary.

13th Aldermanic District

S. 20th St. – W. Grange Ave. to W. Layton Ave. (ST320020801):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, and grading.

14th Aldermanic District

S. Robinson Ave. – E. Ward St. to E. Becher St. (ST211050150):

Asphalt pavement resurfacing, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, and grading.

Alley between S. Pine Ave., E. Potter Ave., E. Russell Ave. (ST212050111):

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary.

15th Aldermanic District

Alley between W. Center St., W. Clarke St., N. 49th St., and N. 50th St. (ST212050119):

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary.
