6. On 11/24/20 at 4:01am, Milwaukee Police were dispatched to 1993 S. Muskego Avenue for a shot spotter complaint. Upon arrival, officers interviewed the applicant who stated that he was in his upper residence of that location when he observed four subjects, on his surveillance cameras, trying to enter his vehicle. He went outside and confronted the subject who fled the scene and a short time later, heard a gunshot south of his location. Officers interviewed another witness who told officers that he was inside the tavern because the applicant frequently opens the establishment late at night for his friends and co-workers and that he heard the gunshots go off at around 3:57am.

7. On 05/04/21 at 7:07pm, Milwaukee Police, along with the Wisconsin Department of Revenue, conducted a license premise check at 1993 S. Muskego Avenue. Upon arrival, officers entered the establishment to find an unlicensed bartender behind the bar with several patrons. The applicant emerged a short time later and told officers that he has been supervising his employees and the agent from the state began her audit. The audit revealed that a vast majority of the applicant's liquor had no accompanying invoices and 80 liquor bottles were confiscated. A copy of the field report was left with the applicants wife.

This report is typed by PO Roberto SANCHEZ, assigned to District Two, Late shift, as Squad 2320, along with my Squad partner PO Radivoje PUPOVAC, we were in full duty uniform with our badges affixed to the outer most layer of our clothing, we were also wearing our Body worn cameras which were on and operational at the time of this investigation. On Tuesday, November 24, at 4:02 a.m., P.O. PUPOVAC and I, were dispatched to 2224 W. Rodgers St. for a Shotspotter complaint.

While on the scene searching the area we were met by Josephine VARGAS (W/F 06-19-1974), who resides at 1993 S. Muskego Ave., which is a upper level apartment on top of Hamaca Bar. VARGAS stated she observed 4 unknown males breaking into her vehicle which was parked behind her residence. I spoke to her husband who identified himself as Luis GONZALEZ (hispanic/male, 01/20/1971), who stated he was in the bedroom of his apartment when he observed 4 unknown males, on his surveillance cameras attempting to break into his vehicle. GONZALEZ stated he went outside and confronted the subjects. 2 of the subjects fled the scene when confronted, moments later GONZALEZ stated he heard what he thought was a gunshot just south from his direction. GONZALEZ stated he went back inside his residence.

Upon further investigating we were informed by a subject on scene who identified himself as Adrian JUAREZ-HERNANDEZ (Hispanic/male, 03/04/1970) he was inside La Hamaca bar, with a group of people drinking. JUAREZ-HERNANDEZ further stated Gonzalez frequently opens the bar late at night past bar close hours. for his friends and co-workers. JUAREZ-HERNANDEZ stated he was inside the bar with some friends and GONZALEZ when he heard the gunshot go off around 3:57 am.

Justin MERRITT) and 2166 (P.O. Oscar ESPITIA and I) along with Wisconsin Dept. of Revenue Special Agents KING and WALDHERR conducted a tavern inspection at La Hamaca, located at 1993 S Muskego Av.

Upon arrival officers observed an unlicensed bartender behind the bar with several patrons. Soon after entering the premises the licensee, Luis LOPEZ-GONZALEZ, emerged from the stockroom stating that he had been supervising his employee. An audit of product purchases was conducted by Agents KING and WALDHERR. The audit revealed that the vast majority of liquor bottles had no accompanying invoice as required. Agents KING and WALDHERR confiscated 65 open liquor bottles and 15 sealed liquor bottles. No contaminated bottles were found. A copy of the field report was left with Josephine VARGAS, the wife of LOPEZ-GONZALEZ. I did observe any additional violations and no citations were issued.

The hearing before the Licenses Committee will take place virtually on 9/8/2021 at 9:00 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
