Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. 7. On 04/18/13 at 1:43 am, Milwaukee police were dispatched to 1218 W Cherry for an Armed Robbery complaint. Investigation revealed two males robbed an employee and another patron while they were standing outside in front of Lorenzo's bar. Both suspects were armed with guns and obtained property before fleeing the area. Police spoke with the bartender Jimmie Harris, who stated he was inside and didn't observe the incident. Lorenzo's does not have video surveillance inside or outside the bar.

9. **The applicant owes \$225.00 to the city of Milwaukee for Parking Citations with a violation date of 08/02/2004 and a due date of 01/17/2014 under case #04082484.**
10. On 12/14/2013 Milwaukee police responded to a Battery complaint at 9403 West Silver Spring Drive #8. The caller stated he had been at Lorenzo's tavern (1218 West Cherry Street) earlier in the morning and another patron had punched him in the face. The caller received stitches at Mt. Sinai Hospital. Milwaukee police incident report # 133480101 filed.
11. On 01/18/2014 Milwaukee police responded to a Fight at 1206 West Cherry Street. Investigation revealed that a shooting had taken place in front of the tavern located at 1218 West Cherry Street (Lorenzo's). Witnesses told police that an unknown person began shooting at everyone in front of the business with an AK-47. The windows of a vehicle parked outside of the business were damaged as well as the victim being struck multiple times by gunfire. Milwaukee police incident report # 140180008 filed.
12. On 02/22/2014 Milwaukee police conducted a Traffic Stop of a vehicle that was leaving the area of the bar. The driver of the vehicle told officers he and his friends had just left the tavern and observed a fight occurring outside the business. The driver told officers that one or two of the subjects involved in the fight possessed firearms. The officers involved in the traffic stop then went to the business and were told by the applicant that everything was fine.
13. On 02/23/2014 Milwaukee police responded to a Battery Cutting at St. Joseph's Hospital. The victim told police she had been at Lorenzo's (1218 West Cherry Street) around 12:00am when a fight broke out inside the business. The victim decided to leave the business in order to avoid the fight. The victim later noticed she had a small cut on the right side of her abdomen, but does not where or when she received the injury. Milwaukee police incident report # 140540024 filed.

14. On Monday 04/28/2014 Milwaukee police conducted an investigation at 1218 West Cherry Street (Lorenzo's) based on information that the business was open in violation of the plan of operation, which indicated that the business should be closed on Monday. Officers found the business to be open, with several patrons eating and drinking on the premise as well as a lit "Open" sign on the west side of the business. The Class B License displayed at the business includes hours of operation Sunday, Tuesday through Thursday, Friday and Saturday but does not include hours of operation for Mondays. The applicant received two citations and a warning for a Food Dealers violation.

Incident # 14 previously reported, disposition now added on 11/22/15.

15. On 07/26/15 at 2:17 am, Milwaukee police were dispatched to 12th and Cherry for a male shot inside a vehicle. The auto was located at 1218 W Cherry Street. At 2:24 am, a squad was flagged down by security from Mt. Sinai Hospital regarding a gunshot victim that was just brought into the emergency room. It was determined to be the same individual reported to have been shot in the vehicle at 1218 W Cherry Street. Investigation revealed that both the suspect and victim were in the bar prior to the shooting. An argument between the two subjects occurred outside of the bar and the licensee reported hearing the argument and exited the bar in an attempt to resolve the issue. When the licensee thought the issue was resolved, he returned inside the bar. Gunfire then began outside the premise resulting in the victim being shot and later dying from his wounds. Multiply casings from several different guns were recovered from the scene.

16. On 10/17/15 at 1:47 am, Milwaukee police began monitoring the premise located at 1218 W Cherry. Police witnessed 3 male patrons entering the premise at 2:05 am and 2 female patrons shortly after in which the premise has a 2 am closing time. Police entered the premise at 2:17 am and found the bar had their lights on, music was being played and a DJ was operating music equipment. Police also found one subject behind the bar and the licensee was on scene and police counted 14 patrons inside the bar. One patron was observed to have an open 1/2 pint bottle of Remy Martin Cognac and a plastic glass in his hand. On top of the bar were 5 plastic glasses with a green liquid and a bottle of Bud Light. There were patrons seated at the bar and also at tables. Officer spoke with the agent and asked if he was aware of the 2 am closing time for his premise and he acknowledge he knew the closing time.

17. On 05/07/2017 officers checked the 1200 block of West Cherry Street for a possible shooting scene. Officers were unable to locate any evidence that an incident had occurred there. While investigating, officers spoke to the applicant who allowed officers to view video from cameras on the exterior of the business at 1218 W. Cherry Street (Lorenzo Bar). The video did not depict any evidence of a shooting.

18. On 11/13/2017 officers were dispatched to Lorenzo's, 1218 W. Cherry St. The investigation revealed at 11:22pm two subjects looked in the front door. One subject then grabbed a brick and threw it at the door shattering it. The subjects then fled in a vehicle, no entry was gained.

19. On 03/31/2018 officers were dispatched to Lorenzo's, 1218 W. Cherry St for a child custody complaint. The caller was Terry CLINCY, who was still waiting for the paperwork regarding the custody agreement. CLINCY was found to have a suspect card and was taken into custody.

20. On 05/06/2018 at 1:10am officers were dispatched to a shotspotter call in the 1500 block of north 14th St. A shooting victim arrived at Mt. Sinai and indicated she was shot outside of Lorenzo's, bar. The officers located 40 casings in the 1200 block of W. Cherry St. The owner closed the business when officers arrived but came back when the officers asked to view surveillance video.

22. On 08/10/2019 at 2:49am officers were dispatched to a Noise Nuisance in the area of N. 14th St and W. Cherry St. When the officer arrived, she observed multiple vehicles parked in front of Lorenzo's, 1218 W. Cherry St, playing loud music. The officer activated her lights and the crowd dispersed. The officer observed people walking in and out of the bar and two subjects inside with drinks on the bar. The applicant opened the door and stated he lived at the bar and could do what he wanted. The applicant stated the people outside had nothing to do with him. The applicant stated he was mad because he was intoxicated, and could not locate the business license. The officer attempted to speak with the other occupants of the tavern but Mr. Clincy wouldn't let them speak. The officer advised the applicant to follow the tavern rules to avoid citations in the future and he again stated he lived there and he could do what he wanted.

23. On 08/17/2019 at 12:43am officers were dispatched to a Noise Nuisance at 1218 W. Cherry St. The caller stated there were cars parked in front of Lorenzo's playing loud music. The caller stated the subjects standing around the cars did not appear to be going in the bar. The officer spoke with the applicant, who stated he has a problem getting people in his bar, they just stand around outside. He stated the Police need to clear out the people outside because if

they are not in his bar they are not his problem. The officers were outside when a large group exited the tavern stating the bar was closing for the night, complaining because they paid a cover charge and were being kicked out early. The officer spoke with the applicant about the cover charge and he confirmed he was charging but the officer did not observe a sign notifying patrons of the charge. The applicant was provided the number for the tavern car and advised to call if there were people outside causing a disturbance.

24. On 09/22/2019 at 12:33am officers observed several illegally parked cars at Lorenzo's. The officers advised the applicant, who stated he would make an announcement to his patrons to move their cars. At 2:52am the officer drove by and observed 10 cars parked outside the bar. As the officers approached, 10 people exited the bar. The officers observed 4 additional people in the bar and the applicant sitting at the bar with an open bottle of liquor in front of him on the bar. The officers spoke to the applicant, who had slurred speech. He stated he lived there and could drink after closing time.
25. On 11/10/2019 at 1:57am officers observed a large number of cars outside Lorenzo's, which has a closing time of 2:00am. The officers observed the business until 2:10am. They counted 30 cars parked outside and conducted a licensed premise check. As they approached they heard someone yell "You got to go" and 8 people left the bar. They entered and observed approximately 8 people inside including staff. The officer spoke with the applicant and advised him he needed to have the bar cleared out by closing time. The applicant stated it takes time to get people to finish up but stopped himself and just stated he was a bit buzzed and would leave it at that. The applicant was given a warning.
26. On 11/17/2019 at 2:10am officers observed 18 cars parked outside of Lorenzo's, 1218 W. Cherry St, after closing time. The as the officers approached to conduct a licensed premise check they found the front door locked. After knocking several times the officers were let inside. They observed approximately 12 people inside the bar including the applicant. Several people had alcohol on the tables. Upon seeing the officers, the applicant yelled "Everyone out". The officers spoke with the applicant and reminded him it's his responsibility to make sure everyone is out of the bar by the closing time listed on his license. The applicant stated he sleeps on a cot in the back room so that makes the bar his residence and he can have guests over at any time. The applicant was issued a citation for Class B Allow Patron After Hours.

27. On 11/24/2019 at 12:51am officers observed 67 cars parked by Lorenzo's. knowing the capacity of the bar is 65 the officers decided to do a licensed premise check. When the officer approached the door they found it locked. The officers knocked and were let inside by the door man. They asked the doorman if he knew the capacity and the just looked down. The officers then had all patrons exit and counted a total of 134 people inside. The officer asked why the front door was locked and the applicant stated because the glass was broken out and they could not see out the door. The officer asked if the applicant knows his capacity and he responded by asking the officer if he knew the bars capacity. The investigation revealed the bar was charging a cover charge without a sign posted notifying patrons of the charge.

28. On 01/07/2020 a meeting was held at District 3 regarding Lorenzo's, 1218 W. Cherry St. The applicant stated he drinks most nights and was intoxicated the night of the overcapacity violation. The applicant stated he has not had fights or shootings so he doesn't think there is a problem. The applicant stated all the people in the bar after hours are workers, even though they were observed drinking alcohol. He stated he would probably close 30 minutes early to give patrons time to get out. The applicant was issued citations for the 11/17/2019 and 11/24/2019 incidents.
29. On 03/07/2020 at 1:58pm officers responded to a ShotSpotter call at N. 12th and W. Cherry St. While en-route officers were advised that three shooting victims arrived at local hospitals regarding this incident. When the officers arrived they observed the front glass broken at Lorenzo's, 1218 W. Cherry St, and a subject cleaning up the glass. The officer observed several casings on the ground in front of the business. Officers located 9 spent casings and 3 unspent casings in the area. The officers spoke with the applicant who stated there was a fight outside and a subject fired a gun. Witnesses and victims stated there was a fight inside the bar between 5 females and security kicked everyone out. Once outside there was a single gunshot, followed by 5-10 shots several seconds later. The bar has cameras but the applicant stated the police have his system since the last shooting. The caller was from the area, no one from the business called regarding this incident.
30. On 03/14/2020 at 1:27am officers conducted a licensed premise check at Lorenzo's, 1218 W. Cherry St. The bar began closing at 1:40pm and the patrons were orderly when leaving the establishment. No violations were observed.
31. On 03/17/2020 at 12:24am officers conducted a licensed premise check at Lorenzo's, 1218 W. Cherry St. The officers advised the applicant of the emergency order requiring business to close. He stated he was aware of the order.

INITIAL INVESTIGATION

This report is written by PO Lydia RIVERA-HOLEY, assigned to District Three, Late Power Shift.

On Saturday, August 10, 2019 at 2:49AM, I, Squad 3465, was dispatched to the area of N 14th St and W Cherry St for a noise nuisance.

Squad 3330, PO KEMNITZ and PO MAROWSKY, Squad 3331, PO BELLO and PO MARX, and 3413, Sergeant WASHINGTON also responded to this call.

Upon my arrival to the area, there were multiple vehicles playing loud music and multiple people standing on the sidewalk and street. There were approximately twenty vehicles and approximately 10-15 people in the area.

This happened in front of Lorenzo's located at 1218 W Cherry St, a tavern in the City and County of Milwaukee, Wisconsin.

I activated the lights of my squad to which people began to disperse and leave the area. I observed people walking in and out of Lorenzo's. I observed two males inside of the bar and lights on inside the location. I observed multiple drinks, an open beer bottle and an open liquor bottle on top of the bar. I knocked on the door to speak to the manager/owner.

A male, later identified as Terry D CLINCY (b/m 06-23-73) opened the door to let me in. CLINCY was very uncooperative and argumentative with me.

CLINCY stated he lived at the bar and could do whatever he wanted. CLINCY stated the patrons of his tavern outside in the street blocking traffic and making noise has nothing to do with him. When asked his name, CLINCY did not respond right away and then answered with "Rob." CLINCY stated he was mad because he was intoxicated. I observed CLINCY to be drinking an open bottle of liquor at the bar. I asked the subjects to provide me with the tavern license, to which they had trouble finding. CLINCY told the other subject to go find another male that was in the area to which he returned with another subject, who found the tavern license and provided it to me.

CLINCY was argumentative. I reminded him about the rules regarding bar close and he repeated he could do what he wants and used profanity. CLINCY stated his license allowed him to stay open until 2:00AM, at which the current time was approximately 3:15AM.

When I read the tavern license, CLINCY admitted his real name, as listed above. One of the males behind

the bar was carrying a glass of dark liquor, to which I pointed out to CLINCY. I asked the male behind the bar if he was a manager and asked for his license. CLINCY would not allow the male to answer me and stated he had no managers and that he was the only one in charge. CLINCY told the male not to give me his license and told him to leave. The male exited out of the front door.

I explained to CLINCY that he needed to follow the tavern rules so he would not have to receive citations in the future. CLINCY stated again he could do what he wanted because he lived there and that he was doing nothing wrong.

I asked CLINCY to close the bar down to which he continuously replied with "no." CLINCY stated the issues were in front and that he has been needing us to help clear out the area and yelled at officers for not helping with the loitering. CLINCY stated he has been calling Police for help but could not answer when the last time it was that he called the Police. CLINCY told officers to exit his premises. I again reminded CLINCY to follow tavern rules in order to not receive citations in the future and I told him again to close down the bar. Officers exited the tavern and the two males exited and got into a waiting vehicle.

On Saturday, August 17th, 2019 at 12:43 AM, Squad 3341, P.O. Justin YOUNG and P.O. Antonio OBREGON, and Squad 3465, P.O. Ryan FEKETE and I, responded to 1218 W Cherry St, Lorenzo's, for a noise nuisance complaint. I spoke to the caller who wished to remain anonymous at this time but stated that he does live in the 1500 blk of N 13th St and that there were 3 or 4 cars parked along side, towards the rear of Lorenzo's playing loud music with subjects standing around the vehicles but did not appear to be going inside the bar.

Scene Description: Lorenzo's is two story building on the north side of W Cherry street in the middle of the block with a alley/driveway along the west side of the building, a open grass lot to the east of the building, and a fenced in parking lot to the west of the alley/driveway. On the south side of W Cherry St there are two fenced in parking lots divided by an alley way.

Upon arriving on scene I was unable to locate the vehicle's mentioned by the caller but I did observe several cars on W Cherry St with people standing around them with loud music playing. The street was completely parked up with vehicles and the alley to the south of W Cherry St was blocked by vehicles parking in the alley and on the street. There we also several cars parked in the grass lot beside Lorenzo's. Squad 3341 parked on N 12th St with their red and blue lights on and I parked in the grass light facing the front door. I observed approximately 10 to 15 people standing in front and around Lorenzo's and another 10 to 15 people standing by different cars with the doors open and music playing.

I spoke to the owner of Lorenzo's, Terry D CLINCY (M/B 6/27/73), and advised him of the noise nuisance complaint and that the complaint was not against his bar but some of his patrons. CLINCY stated that he has a problem getting people into his bar as people will just stand around outside of his bar and not come in. CLINCY stated that there was nothing he could do and that he needed the police to clear the street for him if it's a problem as if they aren't in his bar they aren't his problem. I asked CLINCY what he would like for us to do and he told us to clear the street so P.O. FEKETE and I started to tell people they can't be standing by cars playing loud music or they would be ticketed when a number of people started to exit Lorenzo's. I was then advised that CLINCY decided to close down early to avoid and other situations. This was at approximately 1:15 AM. I heard several people leaving complain about paying 5 dollars to get in and now getting kicked out early. I asked CLINCY if there was a cover charge and he stated that there is and that they start at \$2 and move up to \$5 as the night goes on. I did not observe any signage for the cover charge. P.O. FEKETE and I stood by as everyone cleared out and left the area. I spoke to CLINCY and reminded him that if he is having a large group outside that isn't coming in and just being loud outside to be proactive and either have his security have them move along or to call the Tavern Squad Cell phone which he had been provided the number for to contact us to provide assistance.

Cherry St. (Lorenzo's) which is in the City and County of Milwaukee. While driving past the bar we observed approximately 15 people standing outside the bar loitering on the sidewalk and in the street. We also observed there to be numerous car that were illegally parked. We made contact with Terry D. CLINCY (b/m, 6-27-73) who stated he owned the bar. We advised CLINCY that he needed to make an announcement inside the bar that the illegally parked cars needed to be moved or they were going to get ticketed and towed and that he needed to tell everyone outside the bar they either needed to leave or go inside they could not stay outside. P.O. WHITFIELD and I road around the bar and parked in the side lot to the east of the bar to keep an eye on the crowd for about another 45min.

Later in the night around 2:52AM we again drove passed to make sure the bar was closed because they are supposed to be closed and done serving at 2:00AM. Upon our arrival we observed there to be approximately 10 cars still outside the bar and about 15 people inside the bar. As we walked up to the doors of the bar about 10 people exited the bar. While standing at the door I observed CLINCY sitting at the bar with a open pint bottle of liquor in front of him on the bar that was half gone. I observed there to be 4 other people still inside the bar and plastic cups to be filled with some liquid all over the bar on tables. As we approached CLINCY you could tell that he was intoxicated because as we were talking to him he had slurred speech and he kept repeating himself. P.O. WHITFIELD asked CLINCY why he was still open to which CLINCY replied "I live here so I can still be here" We advised CLINCY that he was not allowed to have alcohol in the bar after close and that him having an open container in front of him was in violation of this. CLINCY continued to argue with us and continued to say we were picking on him and his bar and this was not fair. We again advised CLINCY he needed to kick everyone out of the bar and that he was open well passed bar close at 2:00AM. CLINCY continued to argue with us and when he stood up he was unsteady on his feet. CLINCY was told to shut down and if he wanted to continue to drink he needed to go to his residence which is above the bar and that the bar does not count as his residence.

I entered and still observed approximately 8 people inside the bar including the owner, bartender and security. I spoke to owner, Terry CLINCY, and advised him that he needed to have everyone cleared out at bar close and not have people still inside the bar past that time. CLINCY started to make an argument that just like it takes people time to leave a big store it takes people time to finish up in the bar but he stopped himself and just said that he was a bit buzzed and he would leave it at that. I told CLINCY that we were giving him a warning and he needed to watch the time closer. Upon entering the bar my partner P.O. LEIBSLE observed that the clock inside the bar actually showed the time to be 2:22 AM.

I advised him that it was his responsibility to make sure everyone was out of the bar by the time listed on his license, which on that night is 2:00 AM. I also pointed out that his bar clock showed that it was 2:22 AM which he stated was the "bar time" but did elaborate why if the clock showed later he was unable to get everyone out of the bar. CLINCY then started to argue with officers stating that if I looked at his license I would see that it was also his home so because he was not making money the people that were still in the bar were just his guests in his house which was also his bar. CLINCY stated that he does not live in the upper that he actually has a cot in the back room which makes the lower his house so he can have people over at any time. Before speaking with us CLINCY did state that he was buzzed.

The prior incident when CLINCY was warned was on 11/10/19 at 2:10 AM (CAD 19-314-0207 /Case 19-314-0018).

Taylor ZUBE and I, conducted a tavern check of Lorenzo's Bar, 1218 W Cherry St. While checking the area I counted the vehicles in the area of the bar and noticed that they had 67 vehicles in the area and their capacity is only 65. I contacted Squad 3412, Sgt William KINGSTON, and advised him of the situation and requested additional squads to conduct a capacity check of this location as I believed the location was well over their capacity.

The location is a first floor of a two story building situation at the northeast corner of 12th Ln and W Cherry St. There are no buildings between 13th St and 12th St on W Cherry other than this building with fenced in parking lots for closed businesses on the south side of W Cherry St and west of N 12th Ln on the north side of W Cherry. there are vacant lots to the east of this location.

Squad 3430, P.O. Lydia RIVERA-HOLEY and P.O. Ryan DOMBECK, Squad 3450, P.O. Devin WHITFIELD and P.O. Jeremie GAINER, and Squad 3412, Sgt KINGSTON, responded to assist with the capacity check. Squad 3450 positioned themselves at the back of the building and monitored the side door while Squad 3450 handled crowd control at the door while I conducted the count with my partner monitoring the interior and Squad 3412 oversaw the check.

Upon arriving on scene I positioned my squad car near the front door of the business and pointed by Squad camera at the door. I then approached the front door with the other officers and activated my Axon Body Camera. Upon reaching the door I noticed that the front door was locked and I had to knock to gain entry. The door was opened and I asked the subject who advised that he was working the door if he knew the capacity for the location. The subject just lowered his head, at which point I looked inside the location and observed that the location was packed with people going far above their capacity. At this point I advised the subject that they needed to turn off the music and turn the lights on and have everyone exit the building for a capacity check. I stood at the front door and counted everyone person as they exited the location with my body camera activated and I used a handheld counter to check my numbers. After the count was completed it was determined that they had 134 people inside the location.

At this time I spoke to the licensee, Terry D CLINCY (M/B 6/27/73), as I entered the bar he stated I don't know what your counting but if you have your number I can talk about it in court and told everyone to go. He stated that he knew he wasn't over capacity and stated that we have been "messaging with him" since he asked for squads to help with his crowds. I asked him if he knew his capacity which he replied with asking me if I knew his capacity which I advised him that it was 65 people. I then asked him if there was a reason his front door was locked upon our arrival and he stated that its because his bar was broken and broke the glass on his door. One of the employees that was working the door mentioned that they can't see outside so they kept the door locked. CLINCY stated that he has had the bar for 12 years without problems but that after he made a comment about an officer that he has been targeted.

Sgt KINGSTON attempted to speak to CLINCY and explain why officers conducted the capacity check he refused to speak to him and stated that he did not want to answer any more questions. As officers were leaving CLINCY stated he wanted to apologize for calling an officer a "bitch officer".

At this time CLINCY brought up the past hours incidents at which point he stated that people stay there because he doesn't leave the bar to go home alone. I asked CLINCY if he lived in the bar because he had stated that in prior contacts that he lives in the bar and that the people that stayed past were guests in his home. CLINCY admitted that he lives else where but he stays there when he has a date.

CLINCY was advised that the issuance of citations would be determined by District 3 Captain NORMAN and that he would want a meeting with CLINCY at the District.

I spoke with P.O. GAINER who stated that the only other door was on the east side of the building and it was barred and padlocked shut and no one attempted to exit that door during the check.

I contacted District 3 Capt. NORMAN and was advised to issue the citation for over capacity.

Clincy was very defensive and slightly argumentative regarding the situations. Clincy stated he would probably close 30 minutes early to ensure people are out of the establishment. Clincy was issued 2 citations regarding an over capacity and having patrons inside bar After hours. Clincy took citations and refused to communicate as he stated he just wanted to go. Capt Norman informed him that District three cannot tell him how to run his establishment only can offer suggestions in the scope of police capacity. He was also informed that he knows that it is his responsibility to abide by statutes and ordinances and agreements that of class A liquor license

On Saturday, March 7th, 2020 at 1:58 PM, Squad 3465, P.O. Larry LEIBSLE and I, responded to the area of N 12th St and W Cherry St for a Shotspotter.

This location is a non-residential location with only a single building in the block which is Lorenzo's Bar at 1218 W Cherry St. While en-route to the location we were updated by Squad 3430, P.O. Ryan DOMBECK and P.O. Lydia RIVERIA-HOLEY, that a shooting victim had arrived at Aurora Sinai claiming the incident had occurred at Lorenzo's.

Upon arriving on scene I observed only a few cars parked on the street and no one outside and while approaching the location I observed the front door of the location had its glass shattered and a subject came out the door and started to sweep up the glass. I observed several casings directly in front of the location and instructed the subject to immediately stop cleaning up. At the time of our arrival only 4 people were still inside the location. The owner, Terry CLINCY, his doorman(Clayton GARLAND M/B 1/4/80), his security(Wade J BYRANT M/B 6/29/91), and his clean up guy(Omar HARRIS M/B 5/22/73). I spoke with CLINCY who was visibly intoxicated and asked him what had happened and he told me that a fight occurred outside and someone had shot off a gun breaking the glass on his front door.

A check of the area located 9 spent casings (both 9mm and .40) and 3 unspent rounds as well parts of a firearm magazine.

I was advised by P.O. DOMBECK that three subjects had arrived at the hospital with gunshot wounds connected to this incident. Brandon R PAYTON (M/B 6/30/81) suffered a gunshot wound to his stomach and right leg. Savonta RAWLS (F/B 12/15/82) suffered a gunshot wound to her hip. James E STEAGALL (M/B 6/4/91) suffered a gunshot wound to his right foot.

Several witnesses and victims stated that the incident started with a fight inside the bar between 4 females and a single female and security attempted to break up the fight and then kicked everyone out of the bar at which time 1 single gunshot was fired which struck the front door breaking the glass followed several seconds later by 5 to 10 gunshots.

The location does have visible cameras on the exterior of the location, however CLINCY stated that the "Police" have his system since the last shooting and he hasn't gotten it back yet.

I checked and the only call regarding this incident was from a female that heard gunshots in the area. No one from the location called the police about the incident.


