We received a letter dated August 3, 2021 from the Milwaukee City Attorney's office, which denied our claim for \$2,900.00 for reimbursement of repair charges for damage to our parking lot caused by the City of Milwaukee's DPW during a bulky item pickup (see copy of 8/3/21 letter enclosed). As instructed, I am also enclosing a photocopy of the envelope in which we received the City Attorney's determination.

We are appealing this decision and are requesting that a hearing be scheduled. We are requesting that the hearing date provide adequate lead time to obtain the attendance of our witnesses. Does this hearing panel have subpoena power? If not, how can we compel third party witnesses to appear?


We have received your claim in the amount of \$2,900.00 from a loss on May 25, 2021.


The Assessor's Office information notes that the owner of the property is St. Bernadette Congregation.

The Sanitation Division of DPW has a Collection Service Agreement on file for this property. This holds the City harmless for damages that may occur as a result of the collection process. The Fleet Division of DPW also investigated and determined that there is no evidence that the City was negligent. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.

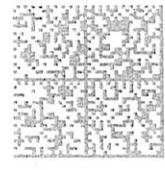
