

**EXTENSION FOR THE FIRST SEMESTER OF THE  
2007-2008 SCHOOL YEAR OF THE  
INTERGOVERNMENTAL AGREEMENT FOR  
SCHOOL SECURITY PILOT PROGRAM  
BETWEEN  
THE MILWAUKEE BOARD OF SCHOOL DIRECTORS  
(BRADLEY TECH)  
AND  
THE CITY OF MILWAUKEE**

**THIS AGREEMENT** is between the City of Milwaukee (“City”) and the Milwaukee Board of School Directors (“Board” or “MPS”).

**WHEREAS**, the City and the Board entered into an Intergovernmental Agreement for a School Security Pilot Program (“Intergovernmental Agreement”) which provided for the assignment of two law enforcement officers to perform the duties of School Resource Officers (“SROs”) at the Lynde and Harry Bradley Technology and Trade School (“Bradley Tech”) to be paid for by the City and covering the second semester of the 2006-2007 school year and specifically expiring on June 15, 2007; and

**WHEREAS**, the Intergovernmental Agreement provided in Section III. that the Intergovernmental Agreement could be extended by the parties to cover the first semester of the 2007-2008 school year under the same terms and conditions without receiving further approval of either the Common Council of the City of Milwaukee or the Milwaukee Board of School Directors. However, an extension of the Intergovernmental Agreement for the first semester of the 2007-2008 school year was to be in writing and executed by the signatories to the Intergovernmental Agreement or their successors; and

**NOW, THEREFORE**, the parties hereby agree to extend the Intergovernmental Agreement for the first semester of the 2007-2008 school year under all of the terms and conditions set forth in the Intergovernmental Agreement.
