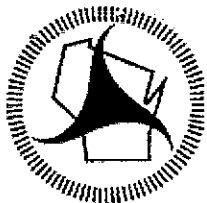

Dear Mr. Leonhardt:

Thank you for providing us with a certified copy of the City of Milwaukee ordinance that was enacted for the collection of a \$20 municipal vehicle registration fee.

Please consider this letter confirmation that the implementation date for the City of Milwaukee municipal vehicle registration fee will begin with December 1st expirations for auto and light truck license plate renewals and original plate issuance. The Wisconsin Department of Transportation will retain an administrative fee of ten cents for each municipal registration fee collected. The payments collected by WisDOT will be returned to the City of Milwaukee no later than 30 days after the end of the month in which they are collected.

To help us better assist customers and to insure a smooth implementation, please provide us with the following:

- Public contact information for the City of Milwaukee (name, phone, address, email address) that DMV can provide to customers with questions regarding the city fee.
- City of Milwaukee contact (name, phone, address, email address) for DMV questions and updates.
- Acknowledgement that the following text is acceptable for DMV to print on renewal notices of affected vehicles: "For autos and light trucks the registration fee shown includes a \$20 fee collected on behalf of your city. For questions regarding the local fee, please contact the city at 414-286-CITY."


