**WHEREAS,** *Nickie's commitment to Bay View goes beyond organized events, as she loves to be out in the community and meeting her neighbors, or volunteering at St. Augustine Church and Larry Under The Bridge; and*

**WHEREAS,** *Nickie's lifetime in Bay View has instilled a deep love for the neighborhood, and her unwavering efforts in community building strive to make Bay View a welcoming and thriving place for everyone; now, therefore, be it*
