
We are in receipt of your claim regarding your son's two cell phones that were taken into police custody for evidence, when the Milwaukee Police Department was dispatched to conduct a welfare check on your son located at 2551 S. 8th Street.

Our investigation reveals that on December 18, 2022, Milwaukee Police Department (MPD) received a call to conduct a welfare check of your son inside the property at 2551 S. 8th Street.

Further investigation reveals that during that welfare check, MPD retrieved a blue Samsung phone with cracked screen and it was placed in inventory and ultimately disposed of.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
