





Dear Sir or Madam:

On December 16<sup>th</sup>, 2004, my vehicle, a 2001 BMW 325i, was towed because from the corner of North Jackson and State streets. The vehicle was ticketed and towed because, it was claimed, the vehicle was not registered and a VIN number was not visible. However, the car was just purchased from a dealership in Illinois, from which I received a temporary Illinois registration which was valid until December 20<sup>th</sup>, 2004. The registration card, about the side of a playing card, was displayed on the dashboard of the vehicle on the driver's side. The VIN number of the vehicle also was typed right on the temporary registration.

After retrieving my vehicle from the tow lot, I noticed that the wheels on the passenger side of the vehicle had some major scrape marks around the edges of the wheels. After inspecting the wheels more closely, I also noticed there was a flap of rubber loose from one of the tire's sidewalls. I informed a tow lot employee of the damage to my vehicle, and he took photographs of the damage. The tow lot employee stated that the vehicle was probably dragged along the curb as it was loaded onto the flatbed tow truck, as well as being dragged along the rails on the side of the tow truck bed, resulting in the black marks on the wheels as well. I took photographs that same day as well, which are enclosed. An estimate for damages is also enclosed with this letter. The estimate includes the replacement of the two damaged passenger side wheels, and replacement of the damaged tire. The dealership informed me that replacing only one tire is not recommended and tires need to be replaced in pairs, otherwise the tires will wear unevenly and vehicle handling will be affected, possibly compromising safety. Therefore they included two replacement tires in the estimate.
