There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkennes; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; thef; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

Hi 1 I'm writing to complain about a bar called Prime Social on north 76st in Milwaukee on Sunday night about 930ish pm I received a phone call from my son he was crying saying Moma some grown security guards men just jumped me for no reason I didn't even do anything I asked him where he was he then told me Prime Social I told him I was on way he said we were leaving the bar it was packed people was shoving out the building and he yelled stop pushing next thing he no someone hit him in the back of his head it was a security guard then about 4 others came and they jumped him he didn't swing back he tried running away they ran behind him attacking him when I made it there I asked to speak to the owner they said that the owner wasn't there I said can I speak to someone in charge the security guard said he was in charge I said was you one of the guards that jumped my son he's (my son) is under age how was he able to get in here and why was he attacked he stated we just escorted him out I said o he was jumped I have footage he then said he was drunk when he wasn't he said the owner will be in tomorrow I called for days and no response from owner I contacted you and called the police the same night until my phone died in middle of conversation when the police station on silver spring was transferred me to dispatch

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 11/28/2019 the applicant was cited in the City of Milwaukee at 5007 W. Center St for Licensed Establishment-Exceeding Occupy Limit.

2. On 01/23/2020 the applicant was cited in the City of Milwaukee at 5007 W. Center St for Licensed Establishment-Exceeding Occupy Limit.

Items #1, 2 updated with disposition

- 3. On 08/29/20 at 1:11am, Milwaukee Police were dispatched to 7225 N. 76th Street for an entry to auto complaint. Investigation revealed that four vehicles were broken into and two firearms were taken. The incident occurred in the western part of the parking lot and there were no surveillance cameras, which would have captured the incident.
- 4. On 12/20/20 at 8:00pm, Milwaukee Police were dispatched to 7225 N. 76th Street for a trouble with subject complaint. Upon arrival, officers interviewed the applicant who stated that his staff had an altercation with a group of females who were attempting to engage in fights. The females left the scene before police arrival and a walk through of the tavern was conducted with no violation observed.
- 5. On 12/27/20 at 8:49pm, Milwaukee Police conducted a license premise check at 7225 N. 76th Street. Officers interviewed the applicant who said that he had no issues tonight, expressed gratitude for police presence, and encourages it.
- 6. On 05/02/21 at 6:43pm, Milwaukee Police were dispatched to 7225 N. 76th Street for a subject with gun complaint. Investigation revealed that security at the location were armed and that there was a large event taking place causing security to walk around the outside of the establishment. Security was cooperative with police and were considered to be doing a reasonable job.

- 7. On 06/21/21 a subject walked into the Seventh District to report a fight which occurred on 06/20/21 at 7225 N. 76th Street. The subject reported that a large fight erupted inside the tavern at 8:00pm and the police were never called. She had a video of the fight which was posted on Facebook. The following day, a District Four officer took a substantial battery complaint from that incident. Also, during the incident, several purses were found to be missing.
- 8. On 07/04/21 at 9:21pm, Milwaukee Police conducted follow-up at 7225 N. 76th Street regarding the incident described in Item #7. Officers interviewed the applicant who stated that he was aware of the fight and said security broke up the two groups and someone called 911 for the injured female. The applicant told officers that medical staff arrived to treat the female and that he was unaware of the missing property. In the video of the incident, there was a subject seen with a firearm. The applicant identified the subject as an employee and said that he was no longer employed with the business. He also said that he has hired a new event staff, implemented a dress code, everyone (including employees) are checked for weapons before entering the establishment, and purchased a high-tech identification scanner.
- 9. On 09/26/21 at 8:55pm, Milwaukee Police were dispatched to 7225 N. 76th Street for a shooting compliant. Investigation revealed that security kicked out a group of subjects and when they were outside, one of them retrieved a handgun and started shooting at the establishment. The group then entered their vehicles and started shooting at the building as they drove off. The actors performed two U-turns and shot at the tavern each time they passed. One person was shot during this incident. Officers were informed that the applicant was telling staff not to speak with officers and that security was seen leaving through the back door in order to avoiding making a statement to police. The applicant did download the ID scanner information for officers. 37 casings were recovered from the scene.

- 10. On 12/13/21 at 1:30am, Milwaukee Police were dispatched to 7225 N. 76th Street for a theft complaint. Officers were met by the applicant who stated that the caller of the theft said security took her purse and he insisted that they did not. Investigation revealed that the caller took a pair of glasses she gifted to her x-boyfriend, who was security, and that security took her purse which contained the glasses. Police found the purse inside the business next to security and returned the glasses.
- 11. On 03/23/22 at 8:29pm, Milwaukee Police were dispatched to 7225 N. 76th Street for a "RES" compliant. Investigation revealed that a married couple were in an argument inside the parking lot of that location and one of the parties rammed their vehicle into the others causing them to fear for their safety.

- 12. On 07/31/22 at 9:30p.m., Milwaukee Police were conducting a license premise check at 7225 N. 76th St., when they were advised by an employee their vehicle had been broken into. The employee stated their purse along with a firearm were stolen. The establishment did not have surveillance cameras outside and there were no witnesses to the incident.
- 13. On 12/21/22 at 7:08p.m., Milwaukee Police conducted follow up regarding a walk-in Theft complaint that was received on 04/14/2022. The employee stated on 04/09/22 at approximately 8:30p.m., their cell phone had been stolen from behind the bar at 7225 N. 76th St. During the follow up it was determined the security cameras do not face the bar area.
- 14. On 01/29/23 at 8:42p.m., Milwaukee Police conducted a License Premise Check at 7225 N. 76th St. No violations were found.
- 15. On 02/02/23 at 8:05p.m., Milwaukee Police conducted a License Premise Check at 7225 N. 76th St. No violations were found.
- 16. On 02/16/23 at 1:11a.m., Milwaukee Police conducted an Investigation at 7225 N. 76th St. Investigation revealed a patron, who was drunk and disorderly, punched a window to the business, causing damage. Officers were later dispatched to a local hospital for a Sick and Injured related to the same incident. The agent did not want to prosecute for the damage and was cooperative with the incident.
- 17. On 03/27/23 at 1:34a.m., Milwaukee Police were dispatched to a Shooting at 7225 N. 76th St. Investigation revealed several patrons entered their vehicle and were exiting the parking lot, when a suspect vehicle started firing shots at the vehicle and the building. A security guard that was preparing the lot for bar close was shot, at which time another security guard exited the building and discharged their firearm at the suspect vehicle, when they also were shot. The occupants of the victim vehicle were all shot and drove themselves to the hospital for treatment. The officers located 15 casings in the parking lot; an unspent casing near the entrance, and one bullet fragment inside the establishment. A subject who identified themselves as "head of security' became uncooperative during the investigation and was cited for their actions.

- 18. On 04/02/23 at 9:20p.m., Milwaukee Police conducted a License Premise Check at 7225 N. 76th St. Officers observed a low capacity crowd and 3 security officers on scene. The agent was on scene and stated they would be closing for the evening as business had been slow since the previous incident. The agent stated their security staff is unarmed and does utilize a metal detector. The agent stated they did provide video surveillance to Milwaukee Police for the previous incident. The agent was advised to request extra patrol if needed.
- 19. On 04/06/23, Milwaukee Police held a meeting with the agent of 7225 N. 76th St., regarding the shooting that occurred on 03/27/23. The Captain of the District was present as well as other entities relevant to the license and operations. The agent stated they have six interior cameras, one of which is operational at the front door, and no operational exterior cameras. The agent stated they are currently in the process of making sure all interior cameras, as well as four exterior cameras are in working order. The agent stated they hire private security and have a minimum of four security officers on scene and call in more, if they are needed. A Milwaukee Police Sergeant that was at the scene of the shooting discussed that security were less than cooperative during the incident and also were not identifiable due to not being dressed in proper attire. Multiple security measures were provided to the agent to avoid any further incident.
- 20. On 09/03/23 at 10:15p.m., Milwaukee Police were dispatched to a Threat at 7225 N. 76th St. The caller was the agent who stated they overheard subjects stating they were going to get guns. The agent stated they were not regular patrons and they didn't know who they were, but they left once police were called to deter any further provocation.

The following are calls for service at 7225 N. 76th St.

21. On 07/08/24 at 1:40p.m., Milwaukee Police took a walk-on theft complaint. The victim stated on 07/06/24 at 10:30p.m., they parked their vehicle at Prime Social Club and when they returned to their vehicle, they found the window damaged and a firearm was missing from the glove compartment.

- 22. On 07/20/24 at 2:00a.m., Milwaukee Police took a walk-in theft complaint. The victim stated while they were inside Prime Social Club an unknown actor shattered the window of their vehicle; however, nothing was taken. The victim stated they attempted to get a parking refund from the business' secured parking lot, however, they refused.
- 23. On 07/20/24 at 11:25p.m., Milwaukee Police took a walk-in Battery complaint. The victim stated at approximately 7:00p.m., they went to Prime Social and presented a ticket for an entertainer at the door. The victim stated a short time later they were surrounded by 4-5 subjects wearing bullet proof vests, pulled our firearms and began to punch the victim. The victim stated they threw a drink at the "security guards" and fled the establishment. The officer left a voicemail for the Agent to contact them regarding possible video surveillance of the incident.
- 24. On 07/29/24 at 2:30p.m., Milwaukee Police took a walk-in Theft complaint. The victim stated they were at Prime Social and parked their vehicle in the lot. When they returned to their unlocked vehicle, they found a firearm was missing from the trunk.

- 25. On 11/02/24 at 12:06a.m., Milwaukee Police conducted a License Premise Check. On arrival officers observed 6-8 security guards on the exterior of the business and patrons in line waiting to be searched. The Agent was on scene and made an announcement to the crowd they were at capacity and would not be allowing anyone else in. While on scene officers observed security escorting two subjects out who were inside causing a disturbance. The business was cooperative.
- 26. On 01/05/25 at 11:59p.m., Milwaukee Police conducted a License Premise Check. Officers observed the business staffed multiple security guards both inside and outside. As the officers were monitoring the crowd they observed security ordering a group of subjects to leave, who were causing a disturbance. The subjects initially went to their vehicles, however, came back and were attempting to physically fight one another. Additional squads were dispatched for crowd control and security was helpful in assisting police with dispersing the crowd.
- 27. On 06/15/25 at 10:00p.m., Milwaukee Police were dispatched to a Noise complaint. On arrival, loud music could be heard from vehicles, however, not from the business. Officers were advised a DJ was playing music outside earlier in the evening, however, moved inside at 10:00p.m. The business was cooperative.

On Monday, July 8th, 2024, at approximately 1:40PM Precious HARRIS (b/f 04-05-1984) walked into Milwaukee Police Department District Seven to report that her vehicle was broken into and to also report that her firearm has been stolen from the vehicle.

HARRIS stated on Saturday, July 8th, 2024, at approximately 10:30PM she was parked near the address of 7225 N. 76th St., in the City and County of Milwaukee (Prime Social nightclub) when she realized that her vehicle (2012, black in color, 2012 Acura TL, WI plate: AWJ-8228, VIN: 19UUA8F55CA021622) front passenger side window was damaged, and the glove compartment was opened/ HARRIS stated that she discovered that her firearm (Glock 43x, black in color, Serial: BYWW374) was missing from the glove compartment.

Harris stated that she called 911 and the telecommunicator informed her to report the incident at MPD District Seven.

HARRIS stated the reason for delayed reporting was due to her being "irritated".

A record check reveals that the firearm is not currently listed as stolen as of Monday, July 8th, 2024. This is HARRIS' first report of a stolen firearm.

I supplied HARRIS with a PV17 and a community contact card regarding this incident. I advised District Four command of the incident who advised me to file the complaint and that he will have follow-up conducted.

This firearm was teletyped to NCIC: MWP70010.

While working the front office at District Four, a female subject walked into the District Lobby at approximately 2:00 AM, on Saturday, July 20th, 2024, to report a property damage complaint.

Interview of Person Reporting the Event: Sharrell M. HALE (B/F 03/26/95)

I spoke to HALE regarding the incident. HALE stated that she went to Prime Social Nightclub at 7225 N 76th St tonight, and at some point, while she was inside the club, an unknown actor shattered the driver's side window of her wife's vehicle 2019 Jeep Grand Cherokee, bearing WI Plate # ADP-1013, VIN 1C4RJFAG3KC617820. HALE stated that she went inside the club around midnight on Saturday, July 20th, 2024, and when she returned to the parking lot at 1:30 AM, the driver's side window of the vehicle was broken, and the hood was popped open, damage was estimated to cost \$400. HALE stated that nothing of value was taken from the vehicle. I did not observe any further damage to the vehicle or steering column. HALE stated that there was nothing of value taken from the vehicle. HALE stated that the employees at Prime Social refused to refund her parking in their secured lot, and that she was filing the report because of that. HALE stated that her wife is the listed owner of the vehicle, identified verbally as Leyah L. ALLEN (B/F 01/01/95). HALE stated that they do not have insurance for the vehicle.

On Saturday, July 20, 2024, at approximately 11:25 PM, I spoke with Lemietric I. BURNS (b/m 01-18-2001) who walked into the District 5 lobby, to report a battery.

BURNS stated on today's date at approximately 7 PM, he had left the Prime Social Bar at the location of 7225 N. 76th St. with his friend, identified as Keith J. LEAVY (B/M 01-30-1996). BURNS stated he and LEAVY went to Prime Social to see a singer named Wavy Ray, perform. BURNS stated when they walked into the door, they presented their tickets for the event, and the security allowed them in.

BURNS stated he ordered a drink and was hanging out when one of the security guards, identified as a black male, approximately 50s, light skin and tall came up to him and told him to come up front.

BURNS stated up front, the security guard questioned him about the ticket he had presented for the event, and stated it was the wrong ticket for that event. BURNS stated the unidentified black male showed the ticket to another worker at the bar, identified as a shorter white male. BURNS stated he told them he had purchased the ticket from Wavy Ray, and they could ask him about it. BURNS stated the shorter white male went to the back to find Wavy Ray, and when he did the first subject, and 4-5 other heavy set black males (presumably security, because several were wearing bullet proof vests), surrounded him.

BURNS stated several of the guards pulled out guns. BURNS described one of the subjects with a gun, Unknown suspect 1, was approximately 30-40 years of age, with light facial hair and a short haircut, medium build, approximately 5'09", caramel colored skin, wearing a bulletproof vest, armed with a black semi-automatic Glock style handgun. BURNS stated the older subject, got in his face and began thumping him in the head with his finger. BURNS stated the guards told him, "Bitch ass nigger, we know what the fuck you're up to."

BURNS stated several of the security guards tried to hit him with closed fists, but they were not hitting him hard. BURNS stated he took the drink that was in his hands and threw it at the security guards, then ran out of the bar and across the street to where he had parked his car.

On Saturday, August 3, 2024, at approximately 1:15 AM, I contacted the District 4 late power tavern car, Squad 4467, P.O. Khalid MAJEED who stated the registered agent at Prime Social is Taylor H. ODEAN (b/m 03-26-1979).

I tried to contact ODEAN through the business phone and the last known phone number for ODEAN but was unsuccessful. I left a voice message requesting ODEAN to call me back. I stated in the message that there may have been an incident on July 20, 2024, at approximately 11:30 PM, and I am requesting to see if there was any video surveillance footage of the bar / restaurant from that night or if he or any of his employees saw anything.

INVESTIGATION

On the mentioned day, the business advertised a Halloween Party event at the establishment and expected a large crowd. Upon arrival, PO MAJEED and I observed that the business was open and operating in a business capacity. I observed that the main parking lot as well as the rear parking lot was filled with vehicles and the entrance to the parking lot was closed off. I observed that patrons were standing outside the building in a line waiting to be searched prior to entering the business. I observed approximately 6 security guards on the exterior of the building along with two additional patron security guards.

I then observed that business owner, Odean H. TAYLOR, standing outside of the main entrance door. TAYLOR stated that the building was near capacity and he made the announcement that no one else would be allowed to come inside the building. I observed that TAYLOR walked to his security staff and once again made the announcement that no one else would be allowed inside. Once the security guards made the verbal announcement, the patrons standing in the line outside of the building left the premise and returned to their vehicles.
