Subject: Little Cancun Sports license hearing

Good Afternoon Alderwoman Dimitrijevic and License Committee,

I am writing to express my objection to the renewal of the license renewal for Little Cancun Sports located at 3040 S Delaware Ave.

As I have lived at my current address for over 16 years, I can attest that for many years a restaurant has operated in this location with no negative impacts to the surrounding residential neighborhood. This has changed since Little Cancun has been allowed to operate.

Specifically, I am opposed to the request to add a Disc Jockey as a form of entertainment. I live around the corner from this restaurant and have observed a DJ in operation many times throughout the summer, most often on Sunday evenings. The DJ and the equipment are visible through the front (west) facing windows of the facility.

When the DJ is in operation, the volume of the music and bass coming from this location is outrageously loud- it can be heard 7-8 homes away in any direction, at a minimum. I have commented to waitstaff who were outside the building that it is extremely loud and disrespectful to the neighborhood and have received no positive feedback.

This weekly event also creates an atmosphere that is inconsistent with the quiet, family oriented residential neighborhood in which it is located- often there are patrons loitering in front of the restaurant, smoking, drinking, and obstructing the sidewalk. They loiter in their cars as they arrive and leave the facility, and drive erratically and in an unsafe manner.

It is for these reasons that I am opposing this request. I hope to be present on Tuesday afternoon to testify if my work schedule allows.
