No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Limited parking for persons attending meetings in City Hall is available at reduced rates (5 hour limit) at the Milwaukee Center on the southwest corner of East Kilbourn and North Water Street. Parking tickets must be validated in Room 205, City Hall (City Clerk's Office).

This report is written by Police Officer Mary SIKORA, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 10/12/11 an officer observed the applicant operating a taxicab at 433 W. St Paul Ave. The applicant did not have a daily safety checklist filled out for that day. The applicant was cited for the violation, but there is no Municipal Court record for the citation.
2. On 12/12/11 an officer observed the applicant in a taxi stand waiting for a fare at the Intercontinental Hotel, 139 E. Kilbourn Ave. The officer had knowledge that the permit for the taxi he was operating was suspended for failure to appear for a random inspection with the police department. The applicant stated he was just parked in the taxi stand to pay his fee for his inspection at City Hall. The applicant did have a receipt dated 12/12/11. However the applicant did have a trip record sheet with fares listed on it in the car dated 12/10/11 while the permit was suspended.
