Notes:

- Image Preference Surveys held in 2001-02 included a discussion of community issues and environmental preferences in addition to the ranking of the images in the survey. Household surveys were also administered.
- Neighborhood-wide meetings held in 2002 were advertised in the Milwaukee Journal-Sentinel, and community newspapers, the Milwaukee Courier-Star, the Milwaukee Times, and the Milwaukee Community Journal. Announcements were made over WNOV radio. Approximately 5,000 flyers were distributed to community organizations in a mass mailing (using the Citizen Advisory Group mailing list), and given as handouts to the North Central YMCA, Center Street Library and Lena's Food Market bagged with groceries. The Mayor's Office also contacted community organizers with Metcalfe Park Neighborhood Association, Project Respect, and Midtown Neighborhood Association to help get the word out.
- Note: Meetings in 2003 were held with partners, neighborhood stakeholders, the Working Task Force and the consultants (Planning and Design Institute) to synthesize the results of previous public input and to develop the catalytic projects contained in the plan.
- The Preliminary Draft presented in January 2004 was revised as a result of public input to contain more language supporting the development of open space and public amenities, added text on homeowner assistance programs and affordable housing, added emphasis on the importance of developing a Main Street strategy for the Fond du Lac and North commercial corridors, and a section on plan implementation.
