Please reserve two schools for Common Council hearings about a proposed increase in the water rate.

**Sholes Middle School**, 4965 S. 20<sup>th</sup> St., from 6 p.m. to 8:30 p.m. Tuesday, April 16, 2002. The meeting will be hosted by the Common Council's Utilities & Licenses Committee. Because we expect more than 100 persons to attend this meeting we would like it to be held in the auditorium. We will need a sound system with a microphone at a head table with six chairs on the auditorium stage. We also will need a live microphone in the audience for people to use to give testimony to the committee.

**Marshall High School**, 4141 N. 64<sup>th</sup> St., from 6 p.m. to 8:30 p.m. Tuesday, April 23 2002, for a second public hearing on the water rate increase. The meeting will be hosted by Utilities & Licenses Committee. As with the meeting at Sholes, it should be in the auditorium with a head table for six and a microphone at the table for the Utilities & License Committee and a microphone in the audience for people to use to testify. About 100 persons are expected to attend this meeting.

The Americans With Disabilities Act of 1990 requires the city to make an effort to accommodate the needs of disabled individuals who might want to participate in our meetings.
