This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 02/24/2019 at 2:26am officers investigated a theft of firearm at On Your Way Home, 2079 S 8th St. The victim stated he had a gun visible in his pocket while at the tavern. Near closing time the victim got into an argument with two unknown subjects. One of the subjects grabbed the victim's gun and took it, which caused a physical fight. The victim fled the scene when he could not retrieve his gun and the suspects also fled the scene. The applicant stated there is video inside the tavern but she was not able to view it due to a technical problem.
- 2. On 02/24/2019 at 4:16am while investigating a theft of gun complaint at On Your Way Home, 2079 S 8<sup>th</sup> St, officers observed a shell casing on the ground outside the bar. The applicant stated the night prior, at about 8:00pm, she had kicked out a disorderly patron and then heard a gunshot outside. The subject attempted to get back in the bar but was escorted out by other patrons and did not return.
- 3. On 06/25/2019 at 3:46am officers investigated a battery DV complaint. The victim of that incident stated she was at on Your Way Home, 2079 S 8th St. At about 1:14am her boyfriend got into a fight with a male subject and she got into a fight with the girlfriend of that subject. Her boyfriend ran into the business and the boyfriend of the girl she was fighting grabbed a gun and struck her to the head with it. He then pointed the gun at her. She was able to return to the tayern and the suspects fled the scene. The applicant came to the scene and provided the video of the incident to the officers.

- 4. On 07/30/2019 at 4:44am officers investigated a damage to property at 2079 S 8<sup>th</sup> St. The upstairs tenant called and stated he heard glass breaking downstairs. The officers found the window broken and called the applicant. She arrived on scene and stated it appeared no one entered and nothing was missing. She was not able to access the video at this time and stated she would try and email the officers the video at a later time.
- 5. On 09/07/2019 at 2:35am officers conducted a license premise check at On My Way Home, 2079 S 8<sup>th</sup> St, because officers observed ten patrons exiting after closing time. The officers entered and found only the bartender inside. She stated she was having troubles getting the patrons out at closing. The bartender was advised to have the patrons out before closing.
- 6. On 04/04/2020 at 1:10pm officers were dispatched to On My Way Home, 2079 S 8<sup>th</sup> St, for the bar being open in violation of the Governor's Safer at Home order. The officer observed through a window 4-5 people seated at the bar drinking. The officer knocked several times but no one came to the door, which was locked. The officer observed the subjects inside get up and walk out of his view. The officer sat outside for several minutes but observed no further activity.
- 7. On 04/06/2020 at 1:13pm officers conducted a license premise check at On My Way Home, 2079 S 8<sup>th</sup> St, regarding the 04/04/2020 incident. When the officer arrived he found the door locked but observed several patrons inside with open bottles of beer. The officers knocked and the bartender opened the door. The bartender stated the subjects were just doing maintenance. The applicant then came out of the bathroom. The officer advised the business was open in violation of the Safer at Home order. The applicant stated she did not know her boyfriend was opening the bar. The applicant was advised of the 04/04/2020 incident, to which the bartender denied knowing the police were there. The applicant was advised to keep the bar closed until the order was lifted and she stated that this could shut her bar down.
- 8. On 04/10/2020 at 12:30pm officers conducted a license premise check at On My Way Home, 2079 S 8<sup>th</sup> St. The officer found the door locked and the light off. The officer knocked and the bartender opened the door. The bartender allowed officers to check the property for patrons and the officer found the tavern to be empty. The bartender stated he is aware of the odre and he would remain closed.

On Saturday, September 7th, 2019 at approximately 2:35 AM, I conducted a tavern check at On My Way Home Bar, 2079 S. 8th St. after observing approximately ten patrons exiting the bar after closing time.

On arrival I spoke with the bartender, identified as Michele L. SERDYNSKI (W/F, 11-20-1969), who stated she was bar tending. SERDYNSKI stated she was having issues getting patrons to exit the bar prior to close. SERDYNSKI provided me with a valid Class D (0226295) bartender's license. I asked for the Class B tavern license (0206213) which SERDYNSKI provided from behind a bag of chips, which was not view able to the public. SERDYNSKI was advised on the importance of having no patrons left in the bar after closing, and making sure any Licenses are view able to the public. No patrons were inside of the tavern when we made entry. SERDYNSKI was cooperative, and no additional tavern violations were observed.

8th St. (On My Way Home Bar) for the call of a business that was open with patrons actively drinking. The business was willfully violating the "Safer at Home" order by Governor Evers, which instructed all non-essential travel, business and social interactions to cease during the State of Emergency. I was dressed in full Milwaukee Police uniform, with my badge affixed to my outer ballistic vest carrier. I was also equipped with my MPD body-worn TASER Axon camera.

Upon my arrival, I observed approximately four to five male subjects seated at the bar and they all appeared to be drinking. As soon as one of the male subjects observed me at the east-side entry door, he stood up and walked to the other side of the business where I could no longer see him. I knocked at the door and received no answer. I then observed several other subjects get up from the bar and walk out of my view. I then knocked a second time, with my department issued baton in an attempt to ensure that the occupants could hear the knocking. I again received no answer. I also tried the door handle, but the door was locked. I then sat outside the business in my marked squad car for approximately 15 minutes and observed no more activity at the location. No one came to the door while I was at the location.

#### 'SAFER AT HOME' TAVERN CHECK

This report is written by PO Matthew DIENER, assigned to District 2, day shift, squad 2166. On Monday, April 6, 2020, I was advised by PO KNAACK that over the weekend he observed that the tavern 'On the Way Home', located at 2079 S 8th St, was open for business, even under Governor EVERS 'Safer at Home' Order. Myself and squad 2164, PO ACEVEDO, responded to the location at approximately 1:13pm for a tavern check to see if the tavern was open for business. The tavern does not sell food, and is also not a grocer, strictly a tavern, and is listed as being a non-essential business under Governor EVERS executive order for managing the COVID-19 pandemic.

Upon arrival I observed the front door was locked, and as I looked in the window I observed several patrons sitting at the bar with open bottles of Miller High Life beer in front of them. I knocked on the door and after a minute the bartender, identified as Roberto TORRES (w/m, 5-26-62), opened the door and stated that he people in the bar "just cleaning up the place and doing maintenance". I advised TORRES that he's lying to me, and that I can clearly see in plain view open bottles of beer on the bar, along with 2 ashtrays and patrons smoking indoors, which was captured on my Axon BWC. The licensee, Debi DAMRON, then exited the bathroom so I could speak with her. Once inside I observed 3 patrons with at least 2 open Miller High Life beers.

I advised DAMRON this activity is obviously wrong and she knows that the bar shouldn't be open. DAMRON stated that "she didn't know her boyfriend (whom she lives with) was opening the bar", and that she "just came here after work to check in on the place". I told DAMRON that a police officer was here over the weekend and observed the bar open with patrons inside, and that they refused to open the door for the police when he knocked on the door. TORRES then stated that he "never heard them knocking on the door". I advised TORRES that the officer who responded actually knocked on the door loudly with his baton, which was also recorded on his BWC. I advised DAMRON that she has to remain closed until the order is lifted, and that I will be filing a tavern report regarding the incident. DAMRON pleaded with me to not file a PA-33, and stated that the incident is already recorded on camera. I told DAMRON that if the behavior continues to occur that she can be cited and/or ordered in for misdemeanor charges. DAMRON then stated that this could "shut her bar down".

On Friday, April 10, 2020, at approximately 12:30P, I conducted a License Premise Check at On My Way Home Tavern, located at 2079 S. 8th St. This was in regards to an anonymous citizen complaint they were open for business contrary to Governor EVERS, Safer at Home Order due to COVID-19. This business is considered non-essential and therefore should not be operating.

On arrival I found the door to be locked and all interior and exterior lights to be off, however, I was greeted at the door by the bartender: Roberto TORRES W/M 05/26/62. I explained to TORRES of the reason for my license premise check and asked to be allowed to check for patrons in the establishment. TORRES was cooperative and allowed me entrance. I checked the basement, office, kitchen area, and restrooms, and found the bar to be empty. TORRES stated he was aware of the order and stated he had assured other Milwaukee Police Officers that responded previously that he would remain closed. I thanked TORRES for his time and cooperation.



The hearing before the Licenses Committee will take place virtually on 10/20/2020 at 9:55 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.
- Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
