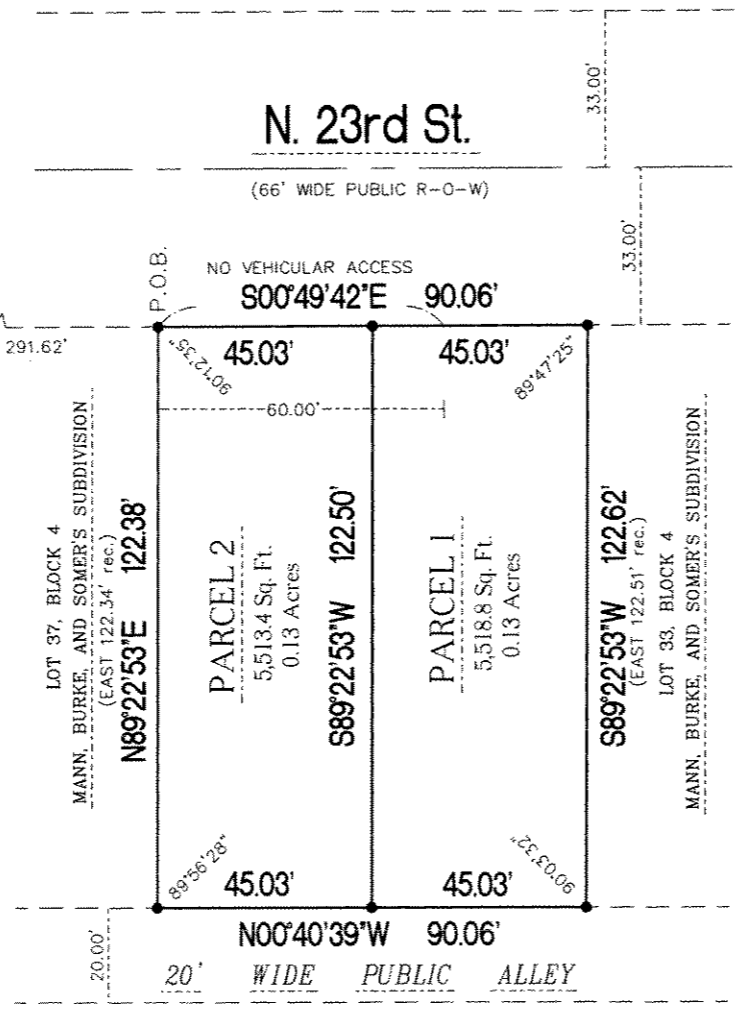

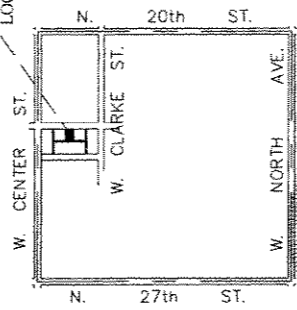

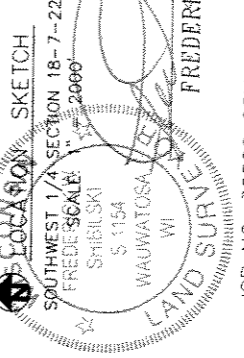


SUBJECT C.S.M. LOCATION

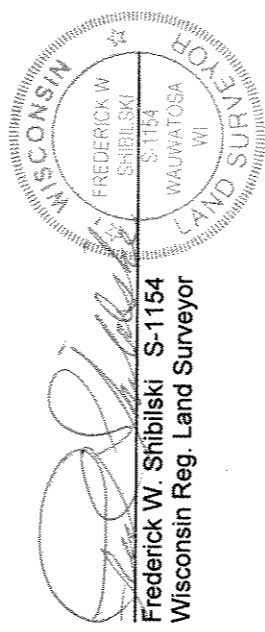

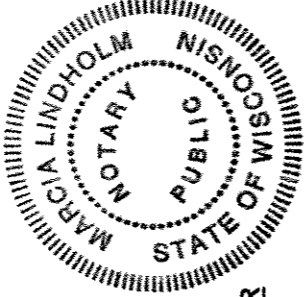
