1. Description of Grant Project/Program (Include Target Locations and Populations):

The Wisconsin Department of Transportation, Division of State Patrol, Bureau of Transportation Safety (BOTS) authorizes MPD to organize and maintain a multi-jurisdictional Traffic Safety Task Force, along with Milwaukee County Sheriff's Office (MCSO) and University of Wisconsin—Milwaukee Police Department (UWM PD). The Task Force is geared towards a High Visibility Enforcement (HVE) effort focused on decreasing traffic crashes and obtaining voluntary compliance with traffic regulations. The most common pedestrian crashes are often due to inattentive motorists and pedestrians. Through a zero-tolerance approach, the Traffic Safety Task Force aims to increase awareness and reduce deaths in Milwaukee.

2. Relationship to City-wide Strategic Goals and Departmental Objectives:

Pedestrian and bicyclist crashes typically account for approximately 30% of the traffic crash fatalities in Milwaukee each year. 2015 and 2017 marked the years with the highest number of crash fatalities since 2010 at 64 deaths. During 2018, slight decreases in pedestrian and bicyclist deaths helped reduce the overall number of fatalities. For 2019, the Traffic Safety Task Force is another effective means for increasing public safety and reducing the number of fatal and debilitating accidents that occur inside of Milwaukee.
