PLEASE TAKE NOTICE that Jones Law Firm LLC has been retained by Joshua Meisenhelder to represent him in his personal injury matter. This injury occurred as a result of a fall on an unsalted portion of a sidewalk at the intersection of North 6<sup>th</sup> Street and West State Street, which belongs to the County of Milwaukee.

Be further advised that Joshua Meisenhelder currently resides at 6735 W. Wick Place, Milwaukee WI 53219. Notice of the aforementioned incident, injuries and claims for damages is hereby given to you and be advised that Joshua Meisenhelder is making a claim for compensation for the injuries and damages sustained. This notice is being made pursuant to Wis. Stat. §893.80 and is being served on the above named entities in compliance with Wis. Stat. §§ 893.80 and 801.11.

**CIRCUMSTANCES OF EVENTS GIVING RISE TO CLAIM**

On or about March 13, 2013 Mr. Joshua Meisenhelder was observed by police officers after a slip and fall on an unsalted portion of a sidewalk. He was lying on the ground near the southwest curb at the intersection of North 6<sup>th</sup> Street and West State Street. Officers stopped to help Mr. Meisenhelder and observed the sidewalk to be very icy. Mr. Meisenhelder had fallen on an unsalted portion of the sidewalk and was in a tremendous amount of pain.

Mr. Meisenhelder's shoulder was severely injured from the fall and he immediately sought treatment at Aurora Mount Sinai Hospital.


The County has not only a compelling interest, but also, a duty to upkeep the streets, parking lots and sidewalks to protect the individuals who use them. In this case the County failed to do so, leading directly to the injury of Mr. Meisenhelder.
