**AGREEMENT BY AND BETWEEN THE  
MILWAUKEE METROPOLITAN SEWERAGE DISTRICT  
AND THE CITY OF MILWAUKEE  
AMENDMENT NUMBER ONE**

This Amendment Number One, dated 15 February 2002, is made to the Agreement dated 1 October 2000 between the Milwaukee Metropolitan Sewerage District (District) a municipal body corporate and the City of Milwaukee a municipal corporation.

This Amendment will become effective immediately.

Article 2 is amended by deleting the following language:

"Six Hundred Fifty Two Thousand Two Hundred Twenty Dollars (\$652,220)"

and replacing it with the following language:

"Seven Hundred Seventeen Thousand Four Hundred Forty Two Dollars (\$717,442)"

Article 8. is amended by deleting the following language:




All other provisions of the Agreement shall remain in full force and effect.


