Dear Mr. Burg:

This office is in receipt of your claim in the amount of \$760.00, relating to damages sustained to your vehicle on February 2, 2001 when it was allegedly struck by a City snowplow at the intersection of South 13th Street and West Morgan Avenue.

Our investigation reveals that the Fleet Accident Report completed as a result of this incident notes the City snowplow was waiting for traffic to clear to complete his turn. The report further notes you drove around another vehicle in an effort to make the light before it turned red. The primary liability for this accident clearly rests with you. As such, the City cannot accept liability for your loss. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
