

On March 9, 2017 you were mailed a true and correct copy of the findings of fact, conclusions of law, and recommendations of the Licenses Committee with respect to the renewal application for a Class D Operator's license in which the Committee recommended that the license not be renewed based on your second nonappearance. You were further notified that the Milwaukee Common Council would consider the matter at its meeting of Tuesday, March 28, 2017, commencing at 9:00 a.m. in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. You were advised of the right to file written objections and to appear personally or by counsel to address the Common Council. At that date, time, and place, you did not appear, and you did not file written objections to the report of the Licenses Committee. You were not represented by counsel.

Following consideration of the report of the Licenses Committee, the Common Council voted to nonrenew your Class D Operator's license based on your second nonappearance.
