I also suffered a temporary Stroke, I am also dialysis patient, so I was unable to take Physical therapy because, as you know, I Have to go to dialysis treatment three times a week, which takes the most of my energy. In addition, I suffered a neck and a back injury which Causes Falls that I'm not prepared for so here and there I am injured due to these falls, in addition to my injuries, my sons rear window was shattered by the branch. The ambulance and paramedics had to remove the branch off of my body and take me to the hospital. I was told that I have 120 days to why? file suit against the city. at the time of the accident I was in the process of moving out of the neighborhood which I live in. I also was looking for a vehicle for me and my family, so I'm pretty sure that these things shouldn't be too much to ask for due to suffering. that I went through because of this horrible accident while I was in the emergency room, I was temporary unable to move. My whole left side was paralyzed since going to the hospital. I Suffer, temporary Blackout, I fall to the ground so my reasoning for asking for so I won't have any stairs to walk up so that I can safely enter my home and I fall down any stairs. I am asking for a three bedroom home with space To move a wheelchair around in I am also asking for the sum of \$80,000 for pain and suffering, I don't think this is too much for this accident could be much worse. If I had lost my life, we will be talking about something different a long time resident of the city of Milwaukee I have been here almost 50 years it was injured by an Unkept tree in front of my home where I have lived almost 8 years we should have been maintained better by the city. I'm not sure how things go. I am asking for what I think is fair I am hoping to hear from The city of Milwaukee in regards to the situation. My phone number is 414-388-4921.
