Attached is a proposed certified survey map listed as follows:

The Department of City Development received an application requesting approval of this certified survey map on October 17, 2023. Chapter 119 of Milwaukee Code of Ordinances allows the Common Council to conditionally approve certified survey map applications and state in writing any conditions for approval.

The purpose of the map is to reconfigure three parcels for new development. Currently the properties are owned by the City of Milwaukee. These properties will be transferred to Milwaukee Habitat for Humanity, in the future.

Therefore, conditional approval of the above listed map is recommended, with the condition that the final Certified Survey Map shall not be released for recording until Milwaukee Habitat for Humanity has completed acquisition of the parcels currently owned by the City of Milwaukee within the boundaries of this CSM.

ATTACHMENT A

CONDITIONS

The final Certified Survey Map ("CSM") shall not be deemed approved and/or be released for recording until such date that Milwaukee Habitat for Humanity ("MHFH") has completed acquisition of the parcels currently owned by the City of Milwaukee that are included within the boundaries of the CSM. If such acquisition is not completed on or before the date that is one year after the Common Council's conditional approval of this CSM (the "Expiration Date"), as evidenced by MHFH providing a copy of the recorded deed(s) with respect to the acquisition to the Commissioner of the Department of City Development, approval of the CSM shall be deemed denied effective as of the Expiration Date.
