- On 02/14/2010 at 3:11am Milwaukee police responded to sick/injured person call for service at 425 East Capitol Drive (Citgo Gas Station). Investigation revealed a patron slipped and fell approaching the front door of the business. The patron received stitches at St. Mary's hospital as a result of this incident.

13. On 03/17/2021 at 10:08pm officers conducted a license premise check at Citgo gas station at 425 E. Capitol Dr. The officer asked the clerk for the business licenses. The clerk did not know where the licenses were posted and did not have a current phone number for the agent.

- 14. On 07/13/23 at 11:35a.m., Milwaukee Police were dispatched to a Trouble with Subject at 425 E. Capitol Dr. On arrival the caller was no longer on scene, however, officers spoke to an employee who stated they juveniles they were having trouble with were gone. The employee was cooperative with the investigation.

This report is written by PO Sophia ALAMO, assigned to District 5, Late Power Shift, Squad 5448

On 12-09-2023 at approximately 9:13 PM, I was dispatched to the address of 425 E. Capitol Dr. for a Property Damage complaint, which is located in the City and County of Milwaukee.

Upon arrival, I observed bags of chips on the floor, and shelves knocked over. I also observed a window to be broken and a brick next to the window.

I spoke to the Gas Station Clerk who identified verbally as Aman SINGH (A/M 12-18-2001) who stated that on 12-09-2023 at approximately 8:46 PM, 6 subjects entered the gas station and were attempting to steal multiple items.

SINGH stated on the suspects' way out one of them dropped their black iPhone and screw driver by the front door. SINGH retrieved it and stated when they asked for it back he refused. The subjects went into a black Hyundai Elantra with an unknown license plate. SINGH stated S#4 demanded his phone but SINGH refused. SINGH stated S#4 got out of the vehicle and proceeded to throw a brick at the front window.

The business was cooperative with the investigation. The business had no security officers on scene.

I reviewed video surveillance footage. The footage showed Suspect #4 at timestamp 20:59 throw the brick at the window. SINGH did not know how to download the footage, I provided him with my email address and phone number to get into contact with me once they have downloaded the footage.

While on scene, I observed the licenses posted and they were up to date. During my investigation for the theft I did not observe any violations in the licensed premise

This report is written by *Police Officer Tracy SUGGS*, assigned to *District Three, Late Shift, Squad 3330*, while in full duty uniform with Axon body camera activated.

On Tuesday June 4, 2024, at approximately 5:20 am, P.O. Derek KOLB and I, responded to a Property Damage complaint at address 425 E Capitol Dr. which is in the City and County of Milwaukee, Wisconsin.

Upon arrival we observed a broken window located at the east side of the building near the entrance door. We also observed a rock and glass littered on the concrete in front of the broken window. Squad 3321, P.O. Adriana GALVAN reviewed the cameras regarding footage that may have captured the incident but did not observe anything of evidentiary value. While on scene, I observed the licenses posted and they were up to date. During my investigation for *Property Damage* I did not observe any violations in the licensed premise.

Interview with the caller Singh AMAN (W/M, 12-18-2001):

No

I spoke with the caller AMAN (phone # 414-961-2425) who works as a gas station attendant at the Citgo, who stated that at approximately 4:55am 2 unknown young, short black males wearing all black came to the location of 425 E. Capitol Dr. and threw something at the window then ran away. AMAN stated that the two unknown subjects were last seen running westbound on E. Capitol Dr.

AMAN stated that he did not know why the subjects broke out the window and that nothing was stolen.

AMAN did not have access to the cameras but provided us with the owners phone number.

I spoke with the Licensed Premise owner Swaran S. MULTAINI (W/M, 7-16-1956) (phone # 414-916-8010) of the Citgo gas station who was not on scene but stated that he has Nationwide insurance and placed the value of the window at approximately \$1250. MULTAINI was cooperative and gave us access to the cameras. The business did not have any security officer working at the location.

Canvass:

We conducted a canvass of the area but were unable to locate any witness to the incident and no other cameras observed that would have captured the event.

Squad 3321, P.O. Adriana GALVAN reviewed cameras and took photos of the scene and uploaded them to evidence.com.

It should be noted that we contacted DPW for window board up per owners discretion.
