Dear Mr. Newman:

We have received your claim in the amount of \$548.00, relating to damage allegedly sustained to your vehicle on June 8, 2005 when it was towed from 4019 North 6<sup>th</sup> Street to the City's tow lot.

Our investigation reveals your 1979 Ford truck was towed to the tow lot for a Covered/Illegible Vehicle Identification Number. The PT-27 Form that was completed prior to the tow noted the vehicle had scratches, dents, rust throughout and damage to the grill and front bumper. The tow lot records also noted the vehicle had visible overall damage. The vehicle's stick shift also had duct tape on it. The tow lot attendant was interviewed and reasonable care was taken in the vehicle's release. It was noted your vehicle was released to you without incident and you returned later to file a complaint. Since the tow lot was not negligent in this matter, we are denying your claim.


